Corey Pace, Principal -Santiago Hills Elementary School – Parking Lot Issues

Core Pace, Principal, was present at the meeting to discuss the ongoing association parking lot issues. It was discussed that the association would need to implement a possible towing procedure, include potential parking permit program in order to regulate the parking issues at the clubhouse parking lot.

Lifeguard Service Proposal – Safe Swim

Upon a motion duly made by Cox, seconded by Krahelski and carried unanimously, the Board moved to approve the proposal at a total cost of \$13,835.40 and to remind them that the guards must be posted at opposite sides of the pool, and preferably do not live in Park Paseo.

Monument Design and Plan Submittal Proposal -Harvest Landscape

This item was tabled as the Board would like to see a rendering and proposals for a monument on Orange Arrow and Yale and to redesign the monument at the clubhouse.

Landscape Proposals – Harvest Landscape

Upon a motion duly made by Hagadorn, seconded by Krahelski and carried unanimously, the Board moved to approve the proposal to install WeatherTRAK station controllers and to program the controllers throughout the community at a total cost of \$29,700.00 to be paid from reserves and to have management submit all documentation for rebates through the water district. Harvest is also to submit a proposal to replace the sprinkler heads with water efficient heads for which rebates are available.

Upon a motion duly made by Krahelski, seconded by Cox and carried unanimously, the Board moved to approve the proposal to trim trees in various locations at a total cost of \$370.00.
