II. HOMEOWNER FORUM

The following items were discussed by homeowners in attendance at the meeting:

- Timing of renovation and receipt of rebate funds
- Concern for sparse coverage of planting in the turf removal areas

III. WORKSHOP DISCUSSIONS AND OUTCOMES

Review of Global Concerns and Outstanding Items:

a. Turf/Weeds – Need to control (Post and Spray)

Posting will be done on Wednesday February 10 – Spraying done Friday

b. Trenching not done to control run-off

This seems to be a miscommunication on management's Part.

Trenching was not discussed by Harvest or the Chair of the L & A

Committee.

c. Areas along Hicks Canyon East of Yale – turf not eliminated

Posting will be done on Wednesday, February 10 – Spraying done Friday.

d. Prosa area – some plants need to be replaced both perimeter and slope

Harvest will survey this are over the next two weeks and begin replacing any plants that have not thrived. Spot spraying will also occur in this area to keep the weed and grass growth contained.

e. Crape Myrtle Tree next to tennis court/spa did not thrive - needs to be replaced

Harvest will check the irrigation in this area, replace the tree over the next two weeks and add some ground cover or small shrubs.

f. Recreation Center Monument Replacement

The Board and Committee discussed replacing or upgrading the current monument in front of the clubhouse. Harvest will provide some examples of monuments and cost for projects recently completed for next workshop meeting.

B. Area 7 (Orange Arrow (both sides) from Christamon W to Yale

- The turf area has been renovated. The fountain grass will be replaced with large flax at no cost to the association.
- The Board and the L&A Committee discussed renovation of the planters behind the renovated turf area for a total cost of \$13,000, utilizing the \$7,500 excess funds from the turf removal rebate and allocating an additional \$5,500 for the project from the general fund. The design includes utilizing Laurys Nobilis "Little Ragu" Dwarf Bay for

first tier screen in front of wall, second tier of Flax, and placement of a Crape Myrtle in cornier of north side of the street, and Tecomaria for ground cover. Additionally, four trees will be installed on the north side of the street. Gus will work with Harvest to select the locations for the trees to be planted.
