Resolution: That only the island on Lucero East be improved with one (1) new jacaranda at Lucero East and ten (10) 5-gallon Carissas throughout for a cost not to exceed 750.00 with funds to be expended from operating account #6199 (Landscape Other).

Discussion regarding the approval of plant material for Orange Arrow Park was tabled pending receipt of additional information from Harvest Landscape. The Board instructed that Harvest begin the process of killing the grasses there using organic or physical removal methods.

As of November 30, 2016, there was \$95,591.19 available in the landscape enhancement fund remaining from the \$288,000.00 rebate.
