n Monday, March 10, 1997, your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. President Mike Krahelski called the meeting to order at 7:00 p.m. Also present were directors Jeff McCoy, Ernie Jones, Ann Kahn, and Ric Cox, association manager Perry Carter, and two homeowners. The minutes of

the February, 1997 BOD meeting as well as the minutes from the February architectural committee meeting were approved as corrected. The financial records from February 1997 were also approved.


Greg Gilroy led a discussion relative to the upcoming town hall meeting which is to be held on Wednesday March 26th at 8:00 p.m. in the association clubhouse. He noted that he had received a great deal of positive feedback from PPHOA homeowners who want to know more about the upcoming educational forums for

our community. The first town hall meeting will make available community leaders, elected officials, and experts on issues relative to the base closure to answer questions about potential uses of the land. The Board directed management to send thirty-day letters to six homeowners who were delinquent three months in their dues, pre-lien l0-day letters to two homeowners delinquent four months, and one account four-plus months in arrears was sent to our attorney for collection.

The Board approved a motion to renew membership in NIVA (North Irvine Villages Association) at a cost of \$100.00

A homeowner attended to discuss a basketball backboard violation letter and to attempt to work out a solution.

A new statement describing the association's policies and practices in enforcing lien rights, fee and penalty procedures, and a new pre-lien form, all of which conform to CCC Section 1365(d) and 1367(a) were adopted.

Heating of the pools and wader was approved to begin March 28, with lifeguard/security service also provided through April 6th.

A bid for lighting the greenbelt northeast of the Prosa pool using railroad ties and fixtures similar to those in other greenbelt areas was approved at a cost of \$2,750.00 including trenching and electrical wiring. Management was requested to obtain design and equipment proposals to upgrade or replace the play equipment at the Christamon totlot.

Management was also requested to obtain three bids for repairing and re-slurrying the parking lot in front of the clubhouse.

There being no further business to come before the board, the meeting was adjourned at 9:35 p.m.

he Christamon pool/wader and the Prosa pool will be heated to 80 degrees in time for spring break on March 28th and will be heated continuously through the end of the break on April 6th.

During this time a security guard will be on duty at the main pool from 10:00 a.m. until midnight daily to record your key number and sign you in. Lifeguards will be on duty from 12:00 p.m. to 6:00

p.m. at both pool facilities.


Security guards will be on duty at the main pool from 10:00 a.m. til midnight to sign you in. Lifeguards-Noon-6 p.m..

As a reminder, the following association "green tag" access rules will be strictly enforced.

- 1. **GREEN TAGS** are designed for youths 10-13 who may swim without parents **WHEN A LIFE-GUARD IS PRESENT.** Requirements for obtaining and keeping a green tag are paying a \$1.00 fee and:
- A. Applicants must a pass a beginning Red Cross test given by the association's pool monitor/lifeguard.
- B. Green tag holders may not bring guests to pool.
- C. Green tag must be on/with swimmer at all times.
- D. Green tag must not be lent to another. Penalty is loss of green tag privileges for 30 days.
- E. Directions of pool monitor and/or security guard must be obeyed at all times. Penalty for violation is 1) warning, 2) sit-out period determined by the pool monitor, and 3) loss of tag for swim season.

Applications for green tag may be obtained at the clubhouse. I will be happy to review the application in detail at the time of issuance.
