BOARD HIGHLIGHTS

EL TORO AIRPORT REUSE: September Update

n Monday August 11, 1997, your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. First Vice-President Jeff McCoy called the meeting to order at 7:15 p.m. Also present were directors Ernie Jones, Ann Kahn, Ric Cox, and Mike Krahelski, association manager Perry Carter,

and NIVA liaison Greg Gilroy. The minutes of the July 1997 BOD meeting as well as the minutes from the July architectural committee meeting were approved as corrected. The financial records from July 1997 were also approved.

The Board directed management to send thirty-day letters to seven homeowners who were delinquent three months in their dues, and a ten day letter to one account which was four months in arrears.

The Board communicated to

Greg Gilroy that, on advice of legal counsel, it was not able to make contributions to political organizations. The Board again suggested that other educational forums might be a better way for our association to be involved in the El Toro reuse issue.

The Babysitting Co-op requested waived-fee use of the clubhouse for its monthly meetings throughout the year. The request was approved subject to submission of an all-PPHOA roster. The Northstars swim team also requested a waived-fee use of the clubhouse for its awards party on September 5. This was also approved. Management was requested to have an IPD representative (Cont'd on page 3)

he OC Board of Supervisors unexpectedly withdrew from a plan to employ a public relations firm, at a cost of over \$450,000 to OC taxpayers, to promote the positive aspects of a planned airport on El Toro MCAS property.

The Irvine City Council commissioned a study of an


85,000 seat sports stadium for development on the 400-plus acres of base property which lies within Irvine city limits. NFL officials have shown interest in pursuing a viable Orange County site. The 4th District Court of Appeals upheld a lower court ruling that Measure A was legal. Measure A was a 1994 county ballot initiative which passed 51/49% and which directed that El Toro MCAS be converted to a civilian passenger/cargo airport once the Marines vacate.

The El Toro Reuse Planning Authority will evaluate filing another

appeal to be heard by the California Supreme Court, at an upcoming closed-door session.

Pro and anti-airport factions continue to debate the need for a non-aviation plan which would be prepared in tandem with the county funded airport plan. ETRPA is ready to provide the non-aviation plan and has requested county funds to support the cost. The OC Board of Supervisors has requested that all lawsuits against it be dropped first.

Taxpayers for Responsible Planning (TRP) raised over \$100,000 at a wine and cheese party dubbed "No Jets" at the Ritz-Carlton in Dana Point. The money will be used to pay (Cont'd on page 3)

he pool gremlins struck again on Saturday, August 23rd. The Christamon pool and wader had to be closed from 5:00-8:00 p.m. because of human waste in the pool, wader, and on the pool deck.

This situation has occurred numerous times this year, much to the disappointment and frustration of those homeowners who were present hoping to enjoy the pool and wader.

After the last incident, I consulted with our pool service company who has the responsibility of cleaning up the pools and the wader, and it is their belief that the most recent incident and the majority of those prior involve toddlers and adolescent children.

I urgently appeal to those homeowners with children in those age groups to please supervise the children closely and regularly check with them to see if they have any needs that would involve them coming out of the water and visiting the rest room.

Additionally, I also ask that each homeowner who has authorized babysitters to bring children to the pools and wader to instruct them to follow the above procedure to prevent accidents.


Adherence to this procedure could cure or greatly reduce the frustration and expense of having to close the pools and wader. It is practically impossible for the lifeguard or security guard to police this situation and perform their primary responsibilities. Guests with younger children should also be asked by the homeowner to monitor their children closely and to remember that homeowners are responsible for their guests.

Cooperation from all concerned could make having to close the pools or wader a thing of the past.
