n Monday April 13, 1998, your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. President Ann Kahn called the meeting to order at 7:05 p.m. Also present were directors Ric Cox and Ernie Jones, association manager Perry Carter, and five homeowners including Northstars

president Nick Ellis.

The minutes of the March, 1998 BOD meeting as well as the minutes from the March Architectural committee meeting were approved as corrected. The financial records from March 1998 were also approved.

The Board directed management to send thirty-day letters to ten homeowners who were delinquent three months in their dues. and ten-day letters to three accounts which were four months in arrears. A request from a homeowner to have a delin-

quency reduced if a lesser amount were paid in a lump sum was rejected by the BOD.



According to a report by the homeowners present, a young girl was nearly hit while crossing Yale at the crosswalk leading to Santiago Hills. The homeowners requested that we assist in informing the Irvine police department about the potential hazards at the intersection. If you feel that the intersection is dangerous or if you have observed near-collisions, please call John Toolson (in charge of traffic engineering) at 724-7643 or call IPD officer Tim Smith (who has the authority to send officers, radar, and other assistance to the intersection) at 724-7023.

CD's in the amounts of \$80,000 and \$90,000 were approved to be placed in federally insured institutions at the most favorable rate. The BOD approved an EarthCare proposal to install Schefflera and Philodendron in planters north of the pool at a cost of \$329.70.

There being no further business to come before the board, the meeting was adjourned at 9:40 p.m.

TRAFFIC SAFETY ALERT

Reports from homeowners indicate that speeding traffic on Yale is causing dangerous conditions at Yale/Orange Arrow particularly during school hours. If you have observed problems, please report them to Sgt. Tim Smith of the Irvine Police Department at 724-7023. Remember that the original plan for the Yale extension through Northwood Five called for a traffic signal at Orange Arrow.

s a result of the recent homeowner ballot count, the Board of Directors modified the proposed swim team practice schedule and approved the modified schedule as follows:

School schedule: June 1-16 (Mon.-Thurs.) 4:00-7:30 p.m. (4 lanes)

Summer schedule: June 18-August 7 (Mon-Thurs) 2:00-6:00 p.m. (2* lanes)

(Diving board is to remain open for use by recreational swimmers-as it was last year.)

*One additional lane may be used from 2:00-4:00 p.m. at the manager's discretion depending on the level of recreational swim traffic at the time.

Three Saturday swim meets plus an intrasquad practice meet were also approved. One mid-week relay meet was also approved. The times and dates for these meets will be posted on the pool bulletin board by the manager as soon as the ISL finalizes its schedule.

The homeowner ballot vote regarding the basketball backboard issue favored leaving the rules as they presently exist and the BOD voted to maintain the existing rules which presently state the following:

- 1. No basketball boards can be affixed anywhere on the house.
- 2. Portable basketball backboards are permitted on the basis that they must be collapsed and stored from view when not physically in use.

The pools, spa, and wader will continue to be heated from now until the end of summer with lifeguards (both pools-12:00-6:00 p.m.) and security guards (Christamon pool) on duty on weekends until school lets out, and then daily until school commences in September. The pools will remain heated until the end of September-or until the nighttime temperature drops into the 40's.

The office will be closed on Monday, May 25th in observance of the Memorial Day Holiday.
