Community News: Spring Pool Schedule

On Monday March 11, 2002 your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. President Ann Kahn called the meeting to order at 7:00 P.M. Also present were directors Ric Cox, Ernie Jones, Jeff McCoy, and Manager Gus Aarnaes.

The minutes of the February, 2002 BOD meeting

were approved as corrected. The financial material from February was reviewed and approved. The minutes from the February, 2002 Architectural Committee approved meeting were The Action items/ corrected. responses from the February, BOD meeting were 2002 reviewed. The Board directed management to send thirty-day letters to seven homeowners three months in arrears in their dues, and a ten-day letter to two homeowners four months in arrears.

The Board reviewed, discussed, and approved a request for fee-waived usage of the clubhouse for the Santiago Hills 6th grade promotion party.





Manager's Report: Pool Reminders

PLEASE CLOSE POOL FACILITY GATES

Please remember to close the pool facility gates behind you at all times. We must be in the habit of securing the gates to prevent small children from wandering into the pool or spa area unattended. This is a serious liability issue for the entire association.

NO GLASS ALLOWED IN POOL AREAS

Our cleaning crews have noticed that glass containers (particularly beer bottles) are being used in the spa area. Please, under no circumstances should any glass containers ever be used in the spa area or pool areas. Accidents happen, glass breaks, and people can be injured. If any broken glass is ever found in the pool or spa, we must close access to it, and schedule the pool maintenance company to come out and vacuum the pool and/or spa at additional expense to the association.

SATELLITE DISHES

Just a short note to challenge homeowners to consider the potential impact to the appearance of our community if satellite dishes are placed near the front of their homes. Please attempt to locate FCC permitted dishes at the rear of your home, so they will be less visible to your neighbors. Also, please ensure that the cable or conduit is securely and neatly attached, and it is painted to match the color of your house.

UTILITY METER DOORS

Community drive-through inspections reveal that a number of utility meter doors are in need of repair or replacement. For your information: If repair is not possible, or replacement is preferable, Ganahl Lumber will fabricate new utility doors similar to the original. These ventilated, wood slatted, louvered doors are available in two sizes to replace the upper (24" x 38") or lower (24"x24") utility doors at a reasonable cost of \$ 55.00 each. Ganahl Lumber can be reached at (714) 513-3848. Ask for Diane Lukawitz, and note that orders take from one to six weeks for delivery.
