# **Community News Spring Pool Schedule**

On Monday, March 10, 2003, your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Ann Kahn, Ric Cox, Mike Krahelski, Brian Hagadorn, and Manager Gus Aarnaes. minutes of the February, 2003 BOD meeting were approved as corrected. The minutes from the Feb-

ruary, 2003 Architectural Committee meeting approved as corrected. The Action items/responses from the February, 2003 BOD meeting reviewed. The Board directed management to send thirty-day letters to seven homeowners three months in arrears in their dues. One ten day letter was issued this month.

The landscape award was given this month to the Spooner residence of 6 Delamesa West. Congratulations and thanks for improving Park Paseo.

Don Harris, President of Professional Aquatic Safety Services reviewed his ongoing lifeguard services for our association, and answered questions from the board. The Board reviewed and discussed the association policy regarding front yard installation of flagpoles. Our Manager was requested to discuss the policy with our attorney.



# Manager's Report Blackbird Deaths

Recently, there has been an unusually high number of dead Blackbirds (Ravens or Crows?) reported throughout our community. Thus far, authorities believe it could be caused by Newcastle Disease, which is specific to Avian species (particularly devastating to the poultry industry). This disease is not harmful to humans or other animals. It would be most helpful to notify Animal Control at (949) 724-7092, if you notice any bird carcasses and their location. This will facilitate proper disposal. Some residents have asked why our landscape company does not remove the carcasses. For health reasons, it is always best to call for Animal Control for proper disposal of any dead wildlife.

#### FEEDING LOCAL DUCKS

When people start feeding water fowl, they not only harm them nutritionally, but they also cause them to become tame. This is good for a domestic animal, but a wild animal needs to have the natural fear of humans and natural enemies in order to protect themselves. Untamed wildlife will usually run from people. When they lose this fear, they approach people, including those who may intend to harm them.

When Ducks become tame and used to humans, they may not be able to protect themselves from predators. Another reason not to feed Ducks is because of the waste that is left behind. Duck droppings contain bacteria that is not healthy for humans. Too much bacteria left in the water and on land where the Ducks are attracted can be detrimental to your health.

Don't forget, in many areas, Ducks are supposed to migrate to different areas at different times of the year. Feeding the Ducks may be tempting, but please show that you care, by not feeding them.
