The landscape award was given this month to the Bye residence of 25 Prosa.


Congratulations and thanks for improving Park Paseo.

The Manager was instructed to notify the committee that any future major remodel or tear-down projects must be approved by the Board, and must be contingent on a completion date. The Board reviewed an invoice from Coastline Design, Inc. relating to the interior design elements of the clubhouse. The next Board meeting has been scheduled for November 10, 2003.

Manager's Report New Billing Cycle

For cost savings and efficiency purposes, the Board of Directors has authorized a change in the billing cycle. Beginning with the new year, your management office will send out the monthly statement and the Park Press Newsletter by the 26th or 27th of every month in order to assure that homeowners receive their bill before the 1st of the month. Hopefully, this will be more logical for homeowners, since the due date has always been the first of the month. The monthly assessment will continue to be due and payable on the first of every month and will be delinquent 15 days after they are due. This means the late fee of \$10.00 will now be assessed for all payments received after the 15th. This will begin with the January, 2004 statement.

2003 Budget

Under separate cover this month, you will receive a copy of the Association's 2004 annual operating budget as well as certain disclosures required by the California Civil Code.

Reminders

- ** Our guidelines and City Code stipulate that you must have a visible address number on your house and it must be lit at night. This is particularly important for emergency vehicles to locate an address.
- ** Please know that our community streets are not storage lots for unused, abandoned or collectible cars. These vehicles belong in your garage or in an off-site storage facility. You are in violation of our community guidelines as well as city code, which stipulates that vehicles cannot remain parked over 72 hours on city streets. These vehicles must be parked elsewhere.
