# **BOARD HIGHLIGHTS**

On Monday, February 14, 2005, your Park Paseo Board of Directors met at the clubhouse for its post-poned meeting. Present were Directors Ernie Jones, Ann Kahn, Brian Hagadorn, Mike Krahelski, Ric Cox, and Manager Gus Aarnaes. One homeowner was in attendance. This homeowner was present to appeal for additional modifications to an already approved home improvement application.

The minutes of the January 2005 meeting were re-

viewed and approved as corrected. The Action Items and Responses Report from the January 2005 meeting was also reviewed.

The Board agreed to follow up with obtaining a new, corrected insurance binder and then proceeding to change brokers for continuing maintenance of the association insurance needs.

The Northstar Swim Team's request for fee-waived use of the clubhouse for Swim Team Registration was approved.

A recommendation by Earthcare Landscape, Inc. was reviewed and discussed for removal of 12 eucalyptus trees and trimming of 21

others. The manager was instructed to obtain bids from Earthcare as well as one other tree company.

The Board was also prepared to hear an appeal to have architectural violation fines waived, but the homeowner did not attend the meeting, therefore the fines will remain.

Three homeowner letters requesting extensions to bring compliance with architectural violations were reviewed and discussed. Specific requirements were noted to comply with association guidelines to avoid due process involving fines.



# Swim Team Signups set for March 4 & 12




The financial reports for January 2005 were approved subject to final revision by the accountant and annual audit. The Association bank account statements were reviewed and discussed. The delinquent account report was reviewed and discussed, and management was requested to send three 30-day reminder letters. No other letters were required.

The latest update relating to the remodeling effort on the clubhouse was reviewed and discussed. Two recent bid proposals for the kitchen remodel were reviewed and compared. It was agreed to accept the lower proposal from BlueRibbon Design, including a penalty and bonus clause for completion by the end of May. The remodel will involve expansion of the kitchen entry and floor space, as well as new cabinets, counter-top and appliances. Interior trashcans will be installed within a new counter and cabinet unit along a wall opposite the current kitchen entry. This will address the many suggestions by homeowners over 25 years of usage.

The Architectural Committee meeting minutes of January 2005 were reviewed and approved as corrected.

The meeting was adjourned at 9:30 p.m. The next Board meeting has been set for March 14, 2005.

# Manager's Report Welcome Spring

#### TREE TRIMMING

Just a reminder that this community has a regular schedule of tree trimming. The large windrow eucalyptus trees that are trimmed on a three-year cycle were trimmed in the early spring of 2003 and will be scheduled again for trimming during the early spring of 2006. The other trees of the community are on a four-year cycle. The jacaranda trees, most of the smaller eucalyptus trees, and many of the other trees of the association were trimmed during the winter of 2002. There are exceptions to this schedule in order to address specific tree problems such as disease, health of the trees, unusual growth, potential safety issues and any other concerns that might necessitate trimming or removal. There is an effort to avoid all trees being trimmed in the same fiscal/ calendar year for budgetary considerations (winter trimming moved to spring and vice-versa).

#### **CLUBHOUSE REMODELING UPDATE**

The Board is in the midst of finalizing the details for a contractor to begin the kitchen remodeling phase for the clubhouse. It is expected that the work will begin the first week of March and is scheduled for completion by the end of May in order to have the clubhouse available for summer use. During this phase of construction, the clubhouse will not be available for use.
