BOARD HIGHLIGHTS

On Monday, September 12, 2005, your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Ernie Jones, Howard Scott, Brian Hagadorn, Mike Krahelski, Ric Cox, and Manager Gus

The minutes of the August 8, 2005 meeting were reviewed and approved as corrected. The Action Items and Responses Report from the August 2005 meeting was also reviewed.

A letter was read to present a homeowner's problem. The

Board decided to table the discussion until the homeowner was able to attend the following BOD meeting scheduled for October 10.

The Board reviewed and discussed the successful and exciting Northstar swim season with the President of the Northstars. She requested a prominent display area for team trophies, awards and placards in the downstairs hall area of the clubhouse and noted a need for an outdoor clock, visible for everyone around the pool. An update relating to the slow progress for diving board insurance was discussed and she was assured she would be notified of any new developments. The Board reminded her of the need for the pool lanes and address unit to be put away in the Northstar enclosure and the

equipment keys to be returned to the office.

A Robco Insurance representative was present to discuss the difficulties and necessary considerations to obtain insurance to cover a diving board for the main pool facility. Other brokers and their findings were discussed. Thus far, the association premiums for insurance would be roughly doubled in cost or add \$2-3 dollars per homeowner per month for the monthly dues. The BOD is awaiting some final legal opinions relating to this insurance issue.

The Board reviewed and discussed the proposed annual meeting mailing material and it was agreed the material, similar to last year's, with the appropriate date and candidate changes (if any) and noted corrections were acceptable. The meeting date was set for October 10, 2005 at 7:00 pm in the Association's clubhouse.

A homeowner's request for fee-waived use of the clubhouse for Junior Girl Scout Troop 1095 was reviewed and

A landscaping violation issue on-going was reviewed and discussed. The Board agreed there would be no more extensions or appeals. The fine process will continue until the landscaping is completed and meets the association guidelines

The Board reviewed and discussed the request by this year's sponsors of the July 4th celebration to continue for 2006. The Board agreed unanimously to allow them to continue to be the lead organizer for the July 4th festivities.

Two bids for a spa emergency shut-off switch were reviewed and discussed. It was agreed to accept the lower of the two proposals as long as there is a timer override to avoid problems with the cycles established for homeowner use. There must be a minimum 5-minute delay per pushing of the switch before the unit turns on again. Also, removing the homeowner key and replacing it must complete the reset.

A bid for re-surfacing the sand-filled main pool tot lot with a rubberized compound to eliminate the sand problem in the pools was reviewed and discussed. The expense was agreed to be too excessive compared to the replacement costs of impellers and filters.

The Board reviewed and discussed a proposal for having an inventory map made up showing the entire tree types and locations within the association common areas. This would help facilitate the tracking of trimming schedules, location of possible problem trees, locations for replacement trees and help define the location and numbers for bidding purposes. The Board questioned whether there might already be such a map from 10 years ago? The manager was instructed to research this.

A proposal for re-modeling the clubhouse office was reviewed and discussed. The manager was instructed to obtain additional and alternate bids and plans.

A proposal for the trimming of some Iron Bark eucalyptus trees by the Prosa pool area was reviewed and discussed. The manager was instructed to proceed.

In response to an inquiry by a prospective buyer, the Board discussed and confirmed the existence of aluminum wiring in many of the association homes. This was permitted under code during the time of construction of these homes.

The General Meeting notes of the North Irvine Villages Association were reviewed and discussed.

The financial reports for September 2005 were approved subject to final revision by the accountant and annual audit. The Association bank account statements were reviewed and discussed. The delinquent account report was reviewed and discussed, and management was requested to send five 30-day reminder letters and one 30-day attorney reminder letter.

The Architectural Committee meeting minutes of August 31, 2005 were reviewed and approved as corrected. The architectural violation log was also reviewed.

The meeting was adjourned at 10:15 p.m. The next Board meeting has been set for October 10, 2005.

Dead Birds


