## **BOARD HIGHLIGHTS**

On Monday, January 9, 2006 your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Howard Scott, Brian Hagadorn, Brian Grochow, Ric Cox, Ernie Jones, and Manager Gus Aarnaes.

The minutes of the December 12, 2005 meeting were reviewed and approved as corrected. The Ac-

tion Items and Responses Report from the December 2005 meeting was also reviewed.

The Board reviewed and discussed another insurance bid proposal to cover the association facilities with or without a diving board. This comprehensive bid was from Berg Insurance Agency.

A rate increase from SBC to \$75.00 from \$55.00 for each of the facility pay phones was reviewed and discussed. Since the need for some kind of emergency phone availability is necessary, the manager was in-

structed to price a 911 phone system only.


The Board reviewed and discussed whether to change the annual landscape and holiday decoration awards. The Board agreed that a \$50.00 gift certificate would also be awarded to the Holiday Decoration Winner.

The Board reviewed and discussed proposals for miscellaneous work to be performed by Earthcare in the association. The proposal was accepted to replace and add another valve as well as add a Quick Link switching device for the lawn area behind Diamante to remedy the low pressure problems for that area. Three architectural violations were reviewed and discussed.

The revised Clubhouse Use Agreement was reviewed and discussed. The manager was instructed to incorporate the additional corrections.

The proposed renewal of the existing association insurance coverage was reviewed and discussed. It was agreed to accept the renewal proposal from Robco Insurance for \$17,685.25.

The Board reviewed and discussed the manager's report relating to the latest city efforts for trimming of windrow eucalyptus trees. The manager wanted to adopt the relevant changes from the city into our upcoming scheduled windrow trimming beginning this February.

An additional windrow trimming bid from Great Scott Tree Services was reviewed and discussed. This bid was significantly higher than two other bids. It was agreed to accept the revised bid from Leonard Chaidez not to exceed \$38,500.00 to trim the windrow trees. Currently, it was agreed to permit the removal of up to five trees if it were deemed necessary.

The General Meeting notes of the North Irvine Villages Association were reviewed and discussed.


The financial reports for December 2005 were approved subject to final revision by the accountant and annual audit. The Association bank account statements were reviewed and discussed. The delinquent account report was reviewed and discussed, and management was requested to send two 30-day reminder letters and two 30-day attorney warning letters.

The Architectural Committee meeting minutes of January 3, 2006 were reviewed and approved as corrected. The architectural violation log was reviewed.

The meeting was adjourned at 9:45 p.m. and the next Board meeting has been set for February 13, 2006.

#### **HOLIDAY DECORATIONS**

Please be reminded again that all exterior holiday decorations must be removed by February 1.

#### WINDROW TREE TRIMMING

All the Windrow Eucalyptus globulus (Blue Gum) trees are scheduled for trimming this February. These very large trees are trimmed every three years. Please inform all in your household, especially the children, of the work in progress and ask that they avoid the work areas in the interest of safety. There will be loud levels of noise, and care must be exercised when walking through the work areas. Heavy equipment will be present and falling branches, leaves, and debris could be a hazard during the trimming period. Thank you for your understanding and cooperation.

#### STREET SWEEPING

The City of Irvine wishes to remind all homeowners of the importance of keeping cars off the city streets on the days of city street sweeping. Each city street sweeper removes about two tons of debris each day that would end up in the Newport Back Bay, and eventually in the ocean. With the help of all residents getting vehicles removed from city streets on sweeping day, the city can continue to assure clean and debris-free streets and storm drain systems without street parking restrictions. Without voluntary compliance on the part of the residents, the City of Irvine may be forced to post street signs with mandatory no parking during hours of sweeping.

#### REPAIR OF VEHICLES

Please be reminded that our association CC & R's are very specific regarding repair of vehicles:
