BOARD HIGHLIGHTS

On Monday, February 13, 2006 your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Howard Scott, Brian Hagadorn, Brian Grochow, Ric Cox, Ernie Jones, and Manager Gus Aarnaes.

The minutes of the January 9, 2006 meeting were reviewed and approved as corrected. The Action Items and Responses Report from the January 2006 meeting was also reviewed.

The Board reviewed and discussed the repair project for

the exterior clubhouse staircase. The manager was instructed to have Mike Nichol, a contractor, commence with the required drawings for a fee not to exceed \$1500.00 in order to obtain bids for the project.

A solution for display of Northstar Swim Team plaques and trophies was reviewed and discussed. After review of possible locations and cabinets, it was agreed to allow for hanging of plaques along the inside wall between the "broom" closet and the doors to the rear outside. Trophies will be kept in the upstairs trophy cabinet.

The Board reviewed and discussed a Northstar Swim Team request for feewaived use of the clubhouse for their board meetings as well as their swim team events. The team was granted

the requested use subject to current group fee-waived use guidelines.

A bid from Leonard Chaidez for trimming and removal of non-windrow trees currently requiring service was reviewed and discussed. The Board instructed the manager to accept the proposal for an amount not to exceed \$3270.00.

A homeowner request for fee-waived use of the clubhouse for Santiago Hills Elementary school 6th grade Promotion party was reviewed and discussed. The Board agreed as long as the group use deposit of \$100.00 is collected.

The Board reviewed and discussed a safety issue relating to children skateboarding on the entry steps to the Prosa pool and in front of the main clubhouse entry. The manager was authorized to have signs made for posting by the Prosa pool steps and in front of the clubhouse area.

SATELLITE DISHES

In order to comply with the Association guidelines and standards that relate to the installation of a satellite dish, consideration must be given to minimizing the visibility of the satellite dish, external cables and related installations. We recommend that all satellite dishes be installed on the rear half of the house (on the patio cover can be fine). Remember that installers are seeking the quickest, cheapest and easiest installation and have been known to claim that the dish has to be in front. Realistically, the satellite dish faces skyward and the rear half of the house is fine. Consideration must be given to your neighbors. Thank you in advance for your cooperation.

Welcome to Park Paseo Board Highlights

(Board Highlights Cont.)

The Board reviewed and discussed the manager's suggestion to allow for the Jacaranda trees in our community to be trimmed before the scheduled 4-year cycle coming up this November, December. The Board agreed to allow the manager to obtain a bid from Leonard Chaidez and instructed the manager to also find when the city is scheduled to trim the Jacarandas they are responsible for.

The Board reviewed and discussed a bid proposal by Ron Wallace Construction to provide for uplifted concrete sidewalk grinds and replacement of missing and damaged slump stone wall capstones. It was agreed to accept the proposal not to exceed \$3,673.00.

The completed removal of the offending slump stone wall addition behind Fortuna West was reviewed and discussed. It was agreed the homeowner must either replace the capstones as existed originally, or must apply for an additional row on top of which the capstones must be placed.

A request was made by the Assistance League of Irvine to include a membership promotion article in the Park Paseo monthly newsletter. It was agreed unanimously that this could only be done if a homeowner acts as the contact and sponsor and is identified as such in the article.

The General Meeting notes of the North Irvine Villages Association were reviewed and discussed.


The financial reports for January 2006 were approved subject to final revision by the accountant and annual audit. The Association bank account statements were reviewed and discussed. The delinquent account report was reviewed and discussed, and management was requested to send three 30-day reminder letters.

The Architectural Committee meeting minutes of January 25, 2006 were reviewed and approved as corrected. The architectural violation log was reviewed.

The meeting was adjourned at 10:07 p.m. and the next Board meeting has been set for March 13, 2006.

Manager's Report DIVING BOARD DECISION

After lengthy and thorough review of the pros and cons of having a diving board, the Board of Directors has concluded it is in the best interest of our community not to replace the damaged diving board. Among the compelling arguments against replacement would be the need to increase the monthly dues by \$3.00 per homeowner per month just to cover the additional insurance premium required to cover the diving board. Our current annual insurance premium expense is \$17,685.25 per annum. With a diving board, the annual insurance premium would more than double to over \$36,200.00 and subject the association to ongoing and unpredictable annual premium increases related solely to diving board coverage.

After extensive research and consultation with several insurance brokers, we have discovered that there are no current California admitted insurance carriers that will underwrite a policy for general liability covering a homeowners' association with a diving board. While there are a few nonadmitted carriers willing to provide coverage for our pool and diving board, the quoted premium, as noted above, more than doubles our current annual insurance cost. Additionally, a non-admitted carrier is not subject to regulatory oversight by the California Department of Insurance and in the event of insolvency (admittedly not likely, but possible), we would not be eligible to receive the additional protection of \$500,000.00 coverage per policy from the California Insurance Guarantee Association (CIGA) afforded California admitted carriers in the event of carrier insolvency. While the association has been blessed with many years of safe use of a diving board, the Board of Directors believes that a diving board still poses a significant potential liability issue to the Park Paseo Homeowners' Association. During the period that the diving board was not available, it was noted that the activity and noise level in and around the pool was significantly less than in previous years. The reduced activity and noise level resulted in fewer distractions for our lifeguards and security guards and seemed to make for a more enjoyable pool experience overall for our homeowner families and guests.

The Board has been made aware that there are very few homeowners' associations that currently have a diving board and virtually no new associations are installing them due to the insurance costs and liability concerns. Do we really want to have the liability exposure incurred by having the only diving board within the local community? Though there are arguments both pro and con relating to diving boards, the Park Paseo Board of Directors believes the costs and liability risks are compelling arguments outweighing the benefits and that it is in the best interest of our community to not reinstall a diving board at the main pool.
