BOARD HIGHLIGHTS

On Monday, April 10, 2006 your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Howard Scott, Brian Hagadorn, Brian Grochow, Ric Cox, Ernie Jones, and Manager Gus Aarnaes. Also present were some homeowners to discuss specific violations of community guidelines and Don Harris, President of Professional Aquatic Safety Services.

The Board reviewed and discussed two homeowner appeals relating to parking of commercial vehicles within the association. Because of specific prohibitions in the CC & R's relat-

ing to parking of commercial vehicles within the association and homeowner complaints, the Board agreed that the rules must be enforced. One homeowner's appeal for a variance to allow their contruction related truck to be parked by their home was denied and both homeowners were notified that their commercial vehicle must either be parked inside their garage or outside of the community.

A homeowner was present to show cause why a fine process should not be initiated for an on-going architectural violation relating to the painting of their home. The homeowner requested a variance from the guidelines, and the request was denied. The manager was instructed to redirect the homeowner to the application guide-

lines for compliance and to request a new application be submitted for approval at the next Board meeting.

The Board reviewed and discussed whether or not a fine process should be initiated for an ongoing architectural violation relating to an improper window covering. The Board agreed that the fine process would begin May 1, 2006 if the pieces of paper covering the window were not removed by April 30, 2006.

The Board reviewed and discussed an on-going architectural violation relating to an incomplete restoration of a back-yard slumpstone wall along an association greenbelt. It was agreed that if the wall restoration were not completed by April 30, 2006 (homeowners commitment) the fine process would begin.

The three heavily used barbecues at the main pool were discussed. This may be the last summer (after five years) for some of them. (Continued on page 3)

SWIM TEAM



Welcome to Park Paseo Board Highlights

(Board Highlights Cont.)

Don Harris, President of Professional Aquatic Safety Services, presented this season's proposed lifeguard program. The emphasis was on a modification of previous year's programs to reduce the expense to the association. Coverage would only be modified at the Prosa pool, with a pool monitor instead of a lifeguard to be on duty Monday through Friday.

The preliminary 2005 association audit report from Bradford G. Benton, CPA was reviewed, discussed and approved as corrected. The manager was instructed to discuss the typo errors with Mr. Benton.

The renewal of the Cane, Walker, Harkins LLP retainer agreement for this year was reviewed and discussed. The manager was instructed to renew the agreement.

The Board reviewed and discussed the latest problem relating to skateboarders and the attempted removal of the recently installed barrier gate. The manager noted that the contractor would return to spot weld the nuts in place to prevent removal of this gate.

A bid proposal for trimming of the association Jacaranda trees was reviewed and discussed. The Board decided to table this issue until the next meeting in order to better identify the areas for trimming and to further discuss possible alternative landscaping solutions.

The minutes of the March 13, 2006 meeting were reviewed and approved as corrected. The Action Items and Responses Report from the March 2006 meeting was also reviewed.

The General Meeting notes of the North Irvine Villages Association did not arrive on time for this meeting and will be included in next month's agenda.

The financial reports for March 2006 were approved subject to final revision by the accountant and annual audit. The Association bank account statements were reviewed and discussed. The delinquent account report was reviewed and discussed, and management was requested to send four 30-day reminder letters, three 30-day collection letters and two delinquent accounts to the association attorney for collection.

The Board reviewed and discussed the sewer-line repair/ replacement that was recently completed by the Irvine Ranch Water District under one of the landscaped islands in the community. The Board requested the manager keep in touch with the IRWD and keep abreast of any new developments.

The latest update relating to the clubhouse exterior staircase was reviewed and discussed. The design work is underway, and upon completion of the drawings, work will be scheduled.

The Board reviewed and discussed the office remodeling project. The new ADA compliant office counter will be installed this week. Then the wallpaper will be put up.

The Architectural Committee meeting minutes of March 29, 2006 were reviewed and approved as corrected. The architectural violation log was reviewed.

The meeting was adjourned at 11:00 p.m. and the next Board meeting has been set for May 8, 2006.

Manager's Corner By Gus Aarnaes

DECEASED BIRDS

If you discover deceased birds (or any dead animals) within the community, it would be most helpful if you would notify Animal Control at (949) 724-7092 with a description of the location for proper disposal. For health reasons, it is always best to call animal control for removal of any dead wildlife.

DUCKS

When people start feeding water foul they not only hurt them nutritionally, they also cause them to become tame. A wild animal needs to have the natural fear of humans and other animals in order to survive. After they lose that fear they begin approaching people including those who are looking to harm them. When ducks become tame they may not be able to protect themselves from predators. Another good reason not to feed ducks is because of the waste that is left behind. Duck droppings can contain bacteria that are not healthy for humans. Too much bacteria in the water and on the land where ducks are attracted can be detrimental to you health.


Consider also that ducks need to migrate according to their seasonal needs. By feeding ducks you may be delaying or preventing their migration. We have an especially difficult time with the mess at the Prosa pool. This is very likely caused by a few misguided homeowners who are feeding them. Show you care. Please do not feed the wild ducks.

With the rainy season now behind us (?) many home improvement projects such as repainting, re-roofing, or relandscaping will be undertaken. Be sure to pick up a Home Improvement Application at the clubhouse office. Return the form to the office by the last Tuesday of the month.
