BOARD HIGHLIGHTS

On Monday, July 10, 2006 your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Brian Hagadorn, Brain Grochow, Ric Cox, Ernie Jones, and Manager Gus Aarnaes.

The minutes of the June 12, 2006 meeting were reviewed and approved as corrected. The Action Items and Responses Report from the June 2006 meeting was also reviewed.

A trash and storage violation relating to an improperly stored water heater was reviewed and discussed. The manager was instructed to send a letter to the tenant, notifying

them that a fine will be assessed if the heater is not removed by the end of the month.

The Board reviewed and discussed an on-going parking violation relating to a commercial vehicle and trailer. The manager was instructed to notify the family that the fine process would be held in abeyance for six months as long as no parking violation was observed or reported.

Trash can storage violations were reviewed and discussed. It was agreed that the fine process would be held in abeyance for six months as long as no additional related violations are observed or reported within this period.

The Board agreed to move forward with possible removal of the wrought iron fence surrounding the Prosa pool

tot lot. A thorough analysis of the best way to proceed will take place at a future meeting at the Prosa pool.

Violations of the CC & R's relating to repairs of vehicles within the association was reviewed and discussed. The Board agreed that the fine process would be initiated if this violation is observed or reported again.

The re-occurrence of violations relating to parking of a commercial vehicle within the association by a homeowner was reviewed and discussed. The homeowner will be invited to the next Board meeting by the manager.

The Board reviewed and discussed a timeline for completion of a homeowner's major landscaping project. The manager will instruct the homeowner that they must have an application for the project submitted for review at the next architectural meeting in July.

The Board reviewed and discussed the location, design style and budget for new monument signs.



The recent replacement of the children's wading pool heater was reviewed and discussed. The manager obtained a quorum by telephone to proceed with the unexpected replacement.

The latest details relating to the sump pump's repair and replacement problems were reviewed and discussed. The manager was instructed to proceed with the electrical re-wiring requirements.

The General Meeting notes of the North Irvine Villages Association were reviewed and discussed.

The financial reports for June 2006 were approved subject to final revision by the accountant and annual audit. The Association bank account statements were reviewed and discussed. The delinquent account report was reviewed and discussed, and management was requested to send five 30-day reminder letters, and five 30-day attorney warning letters.

The Board reviewed and discussed the latest update relating to the clubhouse exterior staircase. The wood will be delivered July 10 and expected completion is the following week.


