BOARD HIGHLIGHTS

On Monday, August 14, 2006 your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Howard Scott, Brian Hagadorn, Brain Grochow. Ernie Jones, and Manager Gus Aarnaes.

The minutes of the July 10, 2006 meeting were reviewed and approved as corrected. The Action Items and Responses Report from the July 2006 meeting was also reviewed.

The Board reviewed and discussed a timeline for completion of a major landscaping project. The homeowner requested time until the end of the year for completion of the project. The Board instructed the manager to notify the homeowner they had until

the end of November to complete the front yard landscaping or the association fine process will begin.

The Board reviewed and discussed an on-going parking violation relating to a commercial vehicle. The homeowner did not appear and the Board instructed the manager to notify the homeowner that the fine process will begin upon the next report or observation of this commercial vehicle parked in violation of the The Board reviewed and CC & R's. discussed homeowners' vehicles with commercial signage parked within the community. It was agreed that the CC & R's are clear in prohibiting the parking of commercial vehicles, in sight, within the association. Acceptable solutions were discussed.

The Board reviewed and discussed an on-going architectural violation relat-

ing to a broken utility door. The homeowner did not appear and the Board instructed the manager to notify the homeowner that the fine process will now begin.

The Board reviewed and discussed the latest update letter from a homeowner regarding the progress of the roof installation at their home.

The Board reviewed and discussed a bid from Ron Wallace Construction for possible new monument sign walls. These walls would incorporate the brick pilaster look, which is a major design element of the existing recreation facilities. A monument sign proposal from a sign vendor was also discussed. Completed proposals will be submitted for the next Board meeting.

The Board reviewed and approved the clubhouse painting proposal for the restroom hallways.

The office remodeling project was reviewed and discussed. The restroom hallways, office and outdoor carpeting have been installed. Only the furniture remains to be completed and will be installed in the upcoming weeks.

PARK PASEO NORTHSTARS


The 2006 Northstars swim season officially ended Saturday, August 12th, with the Championship Meet

The Board reviewed and discussed the possible excessive height of two side yard slump stone walls and a front facing fence and gate. The manager was instructed to review the city guidelines and have them available for the next meeting for continuing discussion.

The Board reviewed and discussed an e-mail complaint from a homeowner regarding commercial vehicle parking.

The Board reviewed and discussed a copy of the CC & R's, Uses Prohibited and Permitted, suggested by the manager for possible mailing to the absentee landlords to help inform some of the non-homeowner residents (tenants) of the governing rules of the association. This will be brought up for additional review at the next meeting.

The Board reviewed and discussed the annual renewal of the association membership to the CAI (Community Associations Institute). The Board instructed the manager to renew the membership after discussion with the organization to determine the lowest allowable renewal rate.

The Board reviewed and discussed the necessity to have the remaining aging wood shingle roofs replaced in the neighborhood. The manager was instructed to review this issue with the association attorney for on-going discussion at the next Board meeting.

The Board reviewed and discussed the current escrow-related fees charged by the association. The manager noted they have been unchanged for possibly ten years. It was agreed the manager would conduct a survey of some escrow companies to help determine what if any charges need adjustment.

The General Meeting notes of the North Irvine Villages Association were reviewed and discussed.

The financial reports for July 2006 were approved subject to final revision by the accountant and annual audit. The Association bank account statements were reviewed and discussed. The delinquent account report was reviewed and discussed, and management was requested to send three 30-day reminder letters, and to turn two accounts over to the attorney for collection.

The Architectural Committee meeting minutes of June 28th were approved as corrected. The architectural violation log was reviewed. The Architectural Committee meeting minutes of July 26th were approved as corrected.

The meeting was adjourned at 9:38 pm and the next Board meeting has been set for September 11, 2006.
