### **BOARD HIGHLIGHTS**

On Monday, December 11, 2006 your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Brian Hagadorn, Ric Cox, Howard Scott, Brain Grochow, Ernie Jones, and Manager Gus Aarnaes. The newly seated President, Brian Hagadorn thanked Howard Scott, the previous President, for his service and accepted the President's gavel.

The minutes of the November 13, 2006 meeting were reviewed and approved as corrected. The Action Items and Responses Report from the November 2006 meeting was also reviewed.

The minutes of the November 27, 2006 Annual Membership Meeting, the December 4, 2006 Reconvened Annual Membership Meeting, and the December 4, 2006 Organizational Board of Directors Meeting were approved as corrected.

A homeowner was present to show cause why the association fine process should not be initiated for an on-going architectural violation relating to reflective tinting on windows with a "mirror" effect, which she claimed had been removed. The fine will be suspended after inspection.

Another homeowner was not able to attend, but a letter from his

management company and tenant were presented to show cause why the association fine process should not be initiated for an on-going architectural violation relating to untimely removal of trash cans from the curb. The Board agreed to hold the fine in abeyance for six months, but it will be assessed during this time if the trash cans are not properly removed from sight.

The Board reviewed and discussed a bid from Leonard Chaidez for trimming of the non-Pear trees adjacent to the clubhouse as well as of two Chinese Elms from the greenbelt behind 21 through 25 Eden. This bid was approved by Board members since some additional trees caused the price of the previous bid to be exceeded by \$420.00.


#### **Election Results**

The Board and Association welcome the re-election of Brian Hagadorn and Howard Scott to serve an additional two-year term on the Board of Directors.

Following the certification, the Organizational Meeting was held, electing Brian Hagadorn to serve as President, Ric Cox as 1<sup>st</sup> Vice President, Howard Scott to assume the duties of 2<sup>nd</sup> Vice President, Brian Grochow becomes the Secretary, and Ernie Jones continues as our Treasurer. Again, thank you to all residents for participating in the process.

A recent letter to Patrol One noting need for manager to come on Sunday to unlock the door to the restrooms was reviewed. The manager is to notify Patrol One of the association intent to subtract \$25.00 from their invoice every time the manager or a Board member has to lock or unlock any lock under their responsibility.

The Board reviewed and discussed a homeowner's issue with the noise and visual impact from two basketball units located in a neighbor's backyard. The Board noted the right of the homeowner to enjoy the peace and quiet of his own home and instructed the manager to attempt to determine if a compromise could be reached that might satisfy each homeowner.

The Board reviewed and discussed a homeowner's request for fee-waived use of the clubhouse for a Santiago Hills Elementary holiday staff party. The Board agreed to allow for fee-waived use of the clubhouse for their staff party.

The need for removal of two giant windrow Eucalyptus trees that have died was reviewed and discussed. The Board agreed to have Leonard Chaidez remove and stump the trees for an amount not to exceed \$1400.00.

The Board reviewed and discussed a need by Southern California Edison to install a switch box on the northeast corner of Yale and Orange Arrow. The Board and manager agreed to locate this box in the least obtrusive location, possibly behind the monument sign location.

The Board reviewed and discussed a proposal from Earthcare to rejuvenate a barren stretch of greenbelt lawn that has become hydrophobic. The Board agreed to accept the proposal for \$320.00 to rejuvenate the area. The project will be scheduled for March 2007.

The Board reviewed and discussed the aging Dos-based financial software of the association. The manager was instructed to allocated up to \$2500.00 to acquire a new computer system and Quickbooks software to convert the association to a more modern financial system at a very manageable expense.

The financial reports for November 2006 were approved subject to final revision by the accountant and annual audit. The Association bank account statements were reviewed and discussed. The delinquent account report was reviewed and discussed, and management was requested to send nine 30-day reminder letters and two delinquent accounts to the attorney for collection.

The Board agreed to have their selections for the 2006 Annual Landscape Award winner as well as the Holiday Decoration Award winner to the manager by December 15, 2006.

The Architectural Committee meeting minutes of November 29th were approved as corrected. The architectural violation log was reviewed. The Architectural Committee meeting minutes of July 26th were approved as corrected.

The meeting was adjourned at 9:24 pm and the next Board meeting has been set for January 8, 2007.

#### **Monthly Dues Reminder**

You have already received a copy of the 2007 Budget. Please be reminded that the monthly dues will be \$68.00 beginning with the January, 2007 payment. This is an increase of \$3.00 per month from the previous \$65.00 payment. The payment is due by the first of each month and is late with a \$10.00 late fee charged if received after the 15<sup>th</sup> of the month. A courtesy statement is mailed every month, but failure to receive one does not remove the obligation to pay your assessment by the due date.

#### **Termite Inspections**

Unfortunately, termites are a fact of life in Southern California and our homes are not immune form them. Protect your home investment by keeping ahead of possible damage from these insects. Have your home inspected occasionally and, if necessary, treated periodically and help the community keep the population down and prevent some of the potential spread of these pests.

#### **Holiday Lights**

The holiday lights and decorations were beautiful this year, as always. Thank you for your efforts! Unfortunately, they have to come down and I have to remind everyone to please have all outdoor holiday lights and decorations removed and put away by February 1, 2007. Thank you.

#### **Basketball Unit Reminder**

There will be a number of new basketball backboard units set up after the holidays. Please be reminded that an architectural application must be filled out and submitted to the Architectural Committee for approval. These units are permitted for placement on the private property of the homeowner only. They must be maintained in good order and they must not be placed on the public sidewalk or street.

#### Satellite Dishes

Please help your community minimize the visual impact of satellite dishes. Let's make every effort to keep them out of sight. The association guidelines require that the units be installed on the back half of the house, preferably out of sight from the streets and sidewalks. Remember that the dish company only wants the quickest and cheapest installation and does not care about the aesthetic impact. Does anyone really think they are attractive??


