BOARD HIGHLIGHTS

On Monday, July 9, 2007, your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Brian Hagadorn, Howard Scott, Ernie Jones, and Manager Gus Aarnaes. Directors Ric Cox and Brian Grochow were not in attendance.

The minutes of the June 11, 2007 meeting were reviewed and approved .

The possibility of whether or not the next step in the association fine sequence should be initiated for an on-going architectural violation relating to parking of a commercial ve-

hicle within the association was discussed.

Concerns expressed by a homeowner relating to the planned expansion of a house next door were discussed.

House expansion plans of a homeowner was discussed. The issue of approval was tabled until further inspection of the site by the Board.

A homeowner appealed to have the application fee waived since a basketball unit has been removed. The fee was waived.

The Board reviewed and discussed the proposed purchase of two Knox boxes as required by both the police and fire authority to hold facility keys for access in the event of emergency.

The Board agreed to approve an amount not to exceed \$750.00 for the purchase and installation of the Knox Boxes.

An email relating to the difficult parking situation within the community was reviewed.

Two letters appealing for additional time to replace existing original wood shingle roofs were discussed. Extensions were allowed.


The status of a second easement requested by Southern California Edison on the NW corner of Yale and Orange Arrow was discussed. The Association is awaiting word from SCE



Solutions to the problem of excessively wet and messy restrooms occurring after a swim meet and the resulting impact to homeowners renting the facility afterwards was discussed. The Board agreed to schedule additional janitorial services.

The possibility of officially banning smoking from within both of the association fenced-in pool areas was discussed.

The Board reviewed a homeowner complaint of excessive horseplay in and around the spa making a relaxing environment impossible. They would like to have signs reminding people that the spa is not the same play area as the pool. At this time, due to consideration of other possible signs and a desire to avoid excessive signage, the Board instructed the manager to have an article placed in the newsletter.

The Board reviewed and discussed the General Meeting notes of the North Irvine Villages Association.



Sand Damage

Did you know we are one of very few associations that have a playground with a sand-filled base close to the main pool and wader? The sand wrecks havoc with the filters and pump motors. Please help us all minimize repair and maintenance expenses by not allowing the little ones to run back and forth between the sandbox and pools with the pools collecting the sand.

Spa Etiquette

Just a reminder that many of our homeowners have the expectation of being able to enjoy a relaxing and peaceful immersion in the spa. We can all expect more playful and noisy behavior in and around the swimming pools and wader. But let's control excessive horseplay and noise around the spa area.

Help Protect the Environment

Did you know that as of July 1, 2007, residents with curbside waste pickup service may schedule a pickup for electronic waste, including TV's, computers, VCR's, and other electronic devices as well as universal waste which includes household batteries, and fluorescent tubes and bulbs. Residents are eligible for two bulky item pickups per year at no charge. To schedule a pickup, call Waste Management's customer service center at (949) 642-1191.

And, plastic bags may now be included in the recycle cart as long as they are all placed into another plastic bag and tied or sealed shut (loose plastic bags can create problems during the sorting process). Also, remember that household batteries and fluorescent tubes and bulbs along with electronic devices and expired or unused prescriptions and medicines, as well as paints, cleaners, and chemicals can be dropped off at the Orange Household Hazardous Waste Collection Center at 6411 Oak Canyon of Sand Canyon. The center is open Tuesday through Saturday from 9 a.m. to 3 p.m.

Clubhouse Reservations

The clubhouse is seeing a lot of use and demand. If you are interested in reserving the clubhouse, be sure to reserve well in advance of the needed date. Reservations are only held upon payment of the fee and completion of the rental agreement contract. Only homeowners and residents living within the association may reserve the clubhouse. As a reminder, any homeowner/resident renting the clubhouse must be present during the entire party or event and will be held responsible for the activities and any resulting problems.
