On Monday, September 10, 2007, your Park its regularly scheduled meeting. Present were Directors Brian Hagadorn, Ric Cox, Howard Scott, Ernie Jones, and Manager Gus Aarnaes. Brian Grochow was absent.

The minutes of the August 13, 2007 meeting were reviewed and approved as corrected. The Ac-

tion Items and Responses Report from the August 13, 2007 meeting was also reviewed.

The Board discussed whether 3 different association fine processes should be initiated for on-going architectural violations relating to a sub-par and dying front and side yard, a front wood decorative wall that is leaning and in need of repair or removal, and palm plants overhanging the sidewalk, blocking unimpeded access and usage by pedestrians.

A homeowner's appeal for an exception to be allowed to keep the existing utility doors replaced approximately six years ago, though these doors are in violation of the original louvered design was discussed. Carried by majority vote, the Board agreed the utility doors must be replaced to meet the existing standard which is the original design for the association.

A homeowner's request for fee-waived use of the clubhouse for Girl Scout Troop 1287 was discussed. The Board agreed to this request subject to completion of the contract and receipt of the mandatory \$100.00 deposit.



The Board reviewed and discussed the upcoming annual election. The mailing material was reviewed and upon receipt of the remaining candidate statements, the election material would be mailed to homeowners.

A proposal from Ron Wallace for needed concrete work and block wall repairs was reviewed. The Board agreed to have Ron Wallace commence with the necessary work for the proposed \$2237.00.

The Board reviewed and discussed a homeowner's request for consideration of waiving some or all architectural violation fees. The Board agreed to waive all but \$100.00 of the assessed fines.

The General Meeting notes from North Irvine Villages Association had not arrived for the meeting.

A recess was called to adjourn to Executive session at 9:00 p.m. to review the minutes of the Special Executive Meeting of July 16, 2007, to discuss the issues relating to managing home expansion projects with the Association Attorney. The Board also reviewed and discussed the contract renewal for the association property manager.

The financial reports for August 2007 were approved subject to final revision by the accountant and annual audit. The Association bank account statements were reviewed and discussed. The delinquent account report was discussed, and management was requested to send six 30-day reminder letters and one attorney warning letter to delinquent accounts. The manager noted that one home was recently unexpectedly sold under foreclosure. After discussions with the association attorney, it was determined that \$392.00 would effectively be uncollectible.

The Architectural Committee meeting minutes of August 29, 2007 were reviewed and were approved as corrected. The architectural violation log was reviewed.

The meeting was adjourned at 9:36 pm and the next Board meeting has been set for October 8, 2007.



### Manager's Corner By Gus Aarnaes

#### Plants Overhanging Sidewalks

Please note that the Association CC & R's specifically prohibit any overhanging of plants over a sidewalk that can interfere with the right-of-way of pedestrians. This should be a matter of common courtesy. The CC & R states: (Article IX, Section 7) "no tree, shrub or other planting of any kind shall be allowed to overhang or otherwise to encroach upon any sidewalk or other pedestrian way, from ground level to a height of ten (10) feet. Think in terms of the elderly, people with strollers, and especially children on bicycles, skateboards and scooters who may run into these plants. The potential liability should be of concern.

#### Car Break-In

Recently, one of our homeowners had their car burglarized in their driveway. A door lock was forced and broken and items in the car were stolen. Please do not leave valuables in your cars! If you see someone suspicious, call the police and let them create a presence.

#### **Utility Doors on Zero-Lot Line Homes**

For your information, the utility doors were originally louvered and they must continue to be of a horizontally louvered-type design. Apparently these doors were louvered to allow for appropriate ventilation of the lower compartment which houses the gas meter. There is a real safety concern behind the need for this ventilated design. This office will continue to send letters to homeowners needing to comply with the Association standard.

#### Found Photo in the Clubhouse

A 9  $\frac{1}{2}$  x 11  $\frac{1}{2}$  inch, framed photo of a cute little red-headed tike positioned on or near a tree trunk, has been found in the clubhouse. No doubt lost from one of our many parties in the clubhouse. Please check with me to get this returned properly.

#### **Election Ballot Problem**

Unfortunately, there have been a very few ballots returned to this office that do not comply with the written instructions. These ballots can not be counted. The law is clear, the ballot must be sealed in the green "ballot" envelope and then placed into the white envelope. The return address must be filled in and the homeowner must sign the signature line.

The Election Inspector will check the white envelopes (return address) against a community roster. Next, the Inspector will open all the white envelopes and place the green "ballot" envelopes in a box. Then, with all the green "ballot" envelopes together, the Inspector will begin to open them and tally the votes. This process assures homeowners that the ballot is in fact confidential.

For those who have not yet returned your ballot, please follow the instructions. There is still time to turn in your votes before the election meeting on Tuesday, October 16, 2007.

#### HISTORY OF THE 'JACK-O-LANTERN'

The Jack-o-lantern custom probably comes from Irish folklore. As the tale is told, a man named Jack, who was notorious as a drunkard and trickster, tricked Satan into climbing a tree. Jack then carved an image of a cross in the tree's trunk, trapping the devil up the tree. Jack made a deal with the devil that, if he would never tempt him again, he would promise to let him down the tree.

According to the folk tale, after Jack died, he was denied entrance to Heaven because of his evil ways, but he was also denied access to Hell because he had tricked the devil. Instead, the devil gave him a single ember to light his way through the frigid darkness. The ember was placed inside a hollowed-out turnip to keep it glowing longer.

The Irish used turnips as their "Jack's lanterns" originally. But when the immigrants came to America, they found that pumpkins were far more plentiful than turnips. So the Jack-O-Lantern in America was a hollowed-out pumpkin, lit with an ember.
