BOARD HIGHLIGHTS

On Monday, April 14, 2008, your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Brian Hagadorn, Howard Scott, Ric Cox, Mike Krahelski and Tanja Fournier. Also present was manager Gus Aarnaes.

The minutes of the March 10, 2008 BOD meeting were reviewed and approved as corrected. The Action Items and Responses Report from the March 10, 2008 meeting was also reviewed.

The Board discussed whether three association fine processes should be initiated for on-going architectural violations relating to the parking of three commercial vehicles with racks, tools, cones, etc. in the driveway/street, a front yard rock landscaping, and a satellite dish mounting. The Board agreed to begin association fine processes for two of the violations, with \$25.00 assessed to the homeowners, and the manager noted that one issue had already been resolved.

The Northstar Swim Team facility use schedule was discussed. The Board agreed to the schedule of home meets, photo day, end-of-year party and practices on Mondays through Thursdays. It was also

agreed to allow for the same practice schedule as last year.

The concept, scope and presentation of an Association website was reviewed. Website development will be an

ongoing agenda item at meetings.

A realistic completion date for a lengthy home addition project was discussed. The manager was instructed to invite the homeowner to attend the next BOD meeting to discuss the progress of the project and show cause why the Association fine process should not be initiated.

The Board reviewed a bid proposal for lifeguard services by a possible new vendor. The manager was instructed to invite the current and new vendor to attend the next BOD meeting to present their programs for review.

The Board discussed a particular type of vehicle parking within the Association. It was decided the guidelines may not apply. (Cont. pg. 2)





The Board reviewed and discussed a homeowner's inquiry regarding a construction element in his home. The Board noted that the Association does not have responsibility for any of the construction elements of the individually owned homes.

A schematic for proposed work to cosmetically improve the clubhouse restrooms was discussed. It was agreed to require all bids to be submitted by May 31st.

The Prosa fence replacement project was discussed. The manager was instructed to check with a specific company into demolition of the existing fence as well as possible involvement aluminum replacement.

The Board discussed if there are any types or categories of ads that should not be allowed in the newsletter. The Board agreed to limit all ad contacts to a current homeowner or resident name and phone number. This change will be in effect in the June 2008 newsletter.

The General Meeting notes from North Irvine Villages Association were reviewed.

The financial reports for March 2008 were discussed, and based on the newly adopted quarterly financial reporting, no official approval was required. The delinquent account report was discussed, and management was requested to send four 30-day reminder letters and three attorney warning letters to delinquent accounts and to turn one account over to the association attorney.

Due to timely need, the manager was authorized to replace the existing upper patio deck BBQ's, as well as some umbrellas for the wading pool and Prosa pool.

The Architectural Committee meeting minutes of February 27 and March 26 were reviewed and approved as corrected. The architectural violation log was reviewed.

The draft of the 2007 Audit report was reviewed. The Board instructed the manager to address three questions with the auditor and then email the answers to the Board. Depending on the responses to the questions, the Board members will then reply with their vote. The vote was unanimous to accept the revised audit.

The meeting was adjourned at 9:50 pm and the next Board meeting has been set for May 12, 2008.

Good Neighbor Parking Guidelines

This office has been receiving complaints by homeowners relating to the parking of someone else's vehicles in front of their homes. I believe everyone must understand that with city streets, people are allowed to park anywhere there is a legal space available. But, does being legal mean being considerate? How would you feel if someone else parked in front of your home every day? If you have too many cars and can't fit them in your own garage, driveway, or in front of your own home, why should that become someone else's problem? There are parking spaces available next to green belts and in the entry to most of our streets. None of our streets are so long that a little walk wouldn't do someone good. Please, don't park in front of someone else's home on a regular basis. Let's remember to respect our neighbors and acknowledge that we all have need for parking in front of our homes for guests, family, friends and contractors. Some of us come home late and would like to find a parking space in front instead of someone else's car. A little consideration, courtesy and respect for others can go a long way in keeping Park Paseo one of the best communities to live in!

Additional Parking Notes

It has been noted and observed that cars are sometimes parked in driveways while overhanging or blocking all or part of the sidewalk. I must point out it is illegal to block or obstruct the public sidewalks, which are intended for pedestrian use. You can be ticketed by the Irvine Police Department.

Parking

Please be reminded that vehicles cannot be parked continuously for more than 72 hours at a time without moving them. Moving a vehicle a few inches or feet does not satisfy this requirement. Call the Irvine Police Department at (949) 724-7100 for help with this problem.

Commercial Vehicles

Please be reminded that no commercial vehicles may be parked or stored on any of our streets, excepting for reasonable periods of time for deliveries and/or construction purposes. Our community has limited available parking and commercial vehicles belong at a place of business, not in a residential neighborhood.


