Pool Season Winding Down

Lifeguard Service

Because of decreased activity at the pools since school started, weekend lifeguard service at the main pool from Noon until 6:00 p.m. has been discontinued. There will no longer be any lifeguards on duty on weekends for October.

Lost and Found

Please remember to check the outside lost and found baskets at the main pool facility or check with me regarding any small items that may have been lost or forgotten over the summer. After the end of this month, the remaining items will be donated to Goodwill.

Burned-Out Street Lights

Occasionally, homeowners call me to report a street light out in the neighborhood. For your information, Southern California Edison is responsible for our streetlights and can be reached by phone at (800) 611-1911. Simply follow the voice prompt and report the location by the closest street address. There is also

a number on the street light pole that can be reported. If the light is out intermittently, or occasionally on and off, be sure to include that information.

Plants Overhanging Sidewalks

Please note that the Association CC & R's specifically prohibit any overhanging of plants over a sidewalk that can interfere with the right-of-way of pedestrians. This should be a matter of common courtesy. The CC & R states: (Article IX, Section 7) "no tree, shrub or other planting of any kind shall be allowed to overhang or otherwise to encroach upon any sidewalk or other pedestrian way, from ground level to a height of ten (10) feet. Think in terms of the elderly, people with strollers, and especially children on bicycles, skateboards and scooters who may run into these plants. The potential liability should be of concern.


Photo Contest

BOARD HIGHLIGHTS

On Monday, September 8, 2008, your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Brian Hagadorn, Howard Scott, Ric Cox, Mike Krahelski, and Tanja Fournier. Also present was manager Gus Aarnaes.

The minutes of the August 18, 2008 BOD meeting were approved as corrected. The Action Items and Responses Report from the August 18, 2008 meeting was also reviewed.

The Board reviewed the successful Northstar Swim season and noted that many new young families had joined. The representatives noted the team's future plans for new starting blocks (which may require modification to the existing pool deck), a lane line reel and new computer.

The Sonitrol representative was not able to attend to discuss a hard-wired key fob system.

The upcoming annual election was discussed. The mailing material will be mailed to the homeowners.

A rate increase notification from Earthcare Landscape, Inc. was reviewed, and the BOD agreed to a new monthly rate increase of 1.7% beginning this November.

The latest update on the progress of conversion to the new software by Asyst Data Group was discussed.

The website photo contest was discussed, and the contest will continue for a few more months.

The General Meeting notes from North Irvine Villages Association were discussed.

The financial material for August 2008 was reviewed. Based on the newly adopted quarterly financial reporting, no official approval was required. The delinquent account report was discussed, and management was requested to send five 30-day reminder letters and two attorney warning letters to delinquent accounts and four accounts are to be turned over to the attorney upon the deadline.

The Reserve Data Analysis on-site preliminary report noted the need to increase reserves due to upwardly revised figures because of increased materials and replacement costs. The reserve data figures were approved and the manager was authorized to include the figures in next year's budget.

The preliminary draft and proposals for the 2009 budget were reviewed. There were significant increases relating to the recent three year on-site reserve study, utilities, and vendor charges. Discussion focused on mandatory increases balanced with discretionary reductions in some services

An update report on the restroom renovation project from mid-September to mid-October was discussed.

The Architectural Committee meeting minutes of August 27, 2008 were approved as corrected. The architectural violation log was reviewed.

The next Board meeting will be held on October 13, 2008.

2009 Budget

During October, you will receive your copy of the budget for 2009. Effective January 1, 2009, there will be an increase of \$6.00 in the monthly dues from \$70.00 to \$76.00 to cover the constantly increasing expenses of maintenance, repairs and facility improvements. In these difficult times, the Board has been committed to minimize any increase while providing for the necessary funding to cover the recent on-site reserve fund study requirements as well as projected repair, maintenance and significant utility cost increases. The Board has sought to cut expenses in as many areas as realistically possible.

We believe that even with this increase, your association continues to be one of the finest in Irvine and your Board continues to be committed to maintaining our assets for all of us to enjoy.

Election Ballot Reminder

Please be sure to carefully follow the Instructions enclosed with each Annual Election mailing. All green ballot envelopes must be enclosed in the white envelope with the requested data and signature filled out on the return address corner as noted on the envelope.

The Election Inspector will check the white envelopes (return address and signature) against a community roster. Next, the Inspector will open all the white envelopes and place the green "ballot" envelopes in a box. Then, with all the green "ballot" envelopes together, the Inspector will begin to open them and tally the votes. This process assures homeowners that the ballot is confidential.

For those who have not yet returned your ballot, there is still time to turn in your votes before the election meeting on Tuesday, October 21, 2008. Submitting the ballots by this meeting date can help keep costs down and could enable us to reach the required quorum without having to reschedule for a lower quorum meeting date.


