### **MANAGER'S CORNER**

#### **Home Street Numbers**

Over the years, more house address numbers have been disappearing from our homes. The City Code and the Association guidelines require that the house address be visible from the street, with a lighting source for nighttime visibility.

Here is a copy of the City code governing house numbers: Single-family residential buildings shall display a street address number conforming to the following specifications:

- 1. Numerals shall be located where they are clearly visible from the street on which they are addressed. They shall be of a color contrasting to the background to which they are affixed. Method of attachment shall not include the use of two-sided tape or any material not resistant to weather conditions.
- 2. Numerals shall be no less than four (4) inches in height and illuminated during the hours of darkness. The numerals and light source shall be contained within a single, weather-resistant fixture. The light source shall be provided with an uninter-ruptible A.C. power source or controlled only by a photoelectric device.

Please keep in mind that this law is

for your protection. Because of the layout of some of our streets, the address numbers are not always in logical sequence across the street from each other. When multiple homes adjacent to each other have no visible address, finding the right address can be difficult. Emergency vehicles must not be delayed because of difficulty finding an address during nighttime hours or during inclement weather conditions.

### **Zero-Lot Line Outside Utility Doors**

For your information: the outside utility doors were originally designed with the louvers in order to provide the necessary ventilation to the bottom compartment that house the gas meter. Natural gas is heavier than air and ventilation is necessary in the event of any leakage to allow the gas to escape. There must be ventilation openings in the lower utility door.

Girl Scout Troop 990 is organizing a book drive for the Children Hospital of Orange County on Tuesday, November 4, 2008.


The books will be donated to the hospital to help the child patients in the hospital expand their knowledge and enjoyment of reading books.

### **BOARD HIGHLIGHTS**

### **Manager's Corner Continued**

On Monday, October 13, 2008, your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Brian Hagadorn, Howard Scott, Ric Cox, Mike Krahelski, and Tanja Fournier. Also present was manager Gus Aarnaes.

The minutes of the September 8, 2008 BOD meeting were approved as corrected. The Action Items and Responses Report from the September 8, 2008 meeting was also reviewed.

It was discussed whether or not an association fine process should begin for an on-going architectural violation relating to a deteriorating front yard in need of refurbishing. A letter from the homeowner was included, committing to new softscape with a scheduled completion date within 14 days. No action was required.

Three homeowner requests for fee-waved usage of the clubhouse for Girl Scout Troup #1287, Girl Scout Troop #356, and Brownie Scout Troop #810 were approved. Fee-waived usage of the clubhouse by Cub Scout Pack #693 will be approved upon verification of how many attendees will be present and the ratio of adults to children.

The latest update on the progress of conversion to the new software by Asyst Data Group. Expect to begin training by mid-November

The Board reviewed the final plans for the replacement fence at the Prosa pool. The manager was instructed to obtain a bid for a possible higher fence.

The General Meeting notes from N. Irvine Villages Association did not arrive in time for the meeting.

The financial material for September 2008 was reviewed. Based on the newly adopted quarterly financial reporting, no official approval was required. The delinquent account report was discussed, and management was requested to send five 30-day reminder letters and three attorney warning letters to delinquent accounts and four accounts are to be turned over to the attorney.

The final mailing items for the 2009 budget were approved.

The Board reviewed the restroom renovation project, which was scheduled to be completed October 16.

The Architectural Committee meeting minutes of September 24, 2008 were approved as corrected. The architectural violation log was reviewed.

The next Board meeting will be held on November 10, 2008.

Zero Lot Line Flooding Reminder

With the fall rain season upon us, I must remind homeowners living next to zero-lot line homes of their responsibility to insure that the surface drainage as designed and graded by the original builder must be maintained in order to prevent any flood damage to the neighbor's zero lot line home. Any modification to this natural drainage that causes water damage to the neighbor's home along the zero-lot line is the responsibility of that owner.

The following streets have zero-lot line homes: Entrada, Alba, Eden, Diamante, Prosa, Lucero, Delamesa, Campanero and the east side of Palmatum.

In the past, a few homes have been flooded when earth and debris (e.g. leaves) acting like sponges are allowed to touch the neighbor's house above the seep line (the joint between the house walls and foundation). The seep line is not a waterproof joint, thus flowing or standing water can penetrate into the house. There must be at least a two-inch (2") margin between the earth and the house seep line. Do not allow planters filled with earth against the neighbor's house (above the seep line)! And be aware of mature plants and trees whose roots may block water run-off next to a home.

Remember: Rain or irrigation water must be allowed to drain away from the zero-lot line home. Let's not have any homes damaged by this preventable flooding!

**Autumn Preparation** 

Now is the time to clean and remove any debris from any rain gutters before the rains come. Check your yards for any debris and root growth that might impede the necessary drainage of water.


