TIPS ON SAFEGUARDING YOUR HOME DURING THE HOLIDAYS

The holiday season is approaching, bringing joy, happiness, and new opportunities for everyone—especially burglars. The rise in burglaries is attributed to the mass purchase of merchandise

and the tendency for many of us to let our guard down during the holiday season. We suggest that you follow these security measures to reduce your risk of being a burglar's next holiday victim.

Around The House

Always close your drapes when you're not home so you're not exposing your holiday gifts.

Put lights and radio on timers to make it appear as if you're home even while you're at parties and shopping.

Always remember to lock your doors and windows when leaving, even if it's only for a brief time.

Holiday Shopping

Try to park near a busy entrance to the shopping mall or store.

Carry only \$100 or less in cash when shopping. Many malls have indoor ATM's where you can get money.

Carry only one credit card and use it for all purchases. When resting, don't leave your packages on the ground.

Have your car keys in your hand so you don't have to linger before entering your car. Keys can also serve as a weapon against an attacker.

Avoid setting down your purchases when getting into your car. Put purchases in the trunk, not on the back seat of your car, so potential thieves can't see them.

If you think you are being followed, drive to a public place or police station. If it is unsafe to get out of your car, honk your horn and flash your lights.

If your car breaks down, open the hood and attach a white cloth to your antenna. If someone stops to help, stay in your locked car (windows up) and ask him or her to call the police or a garage.

By following these simple security measures, you can help ensure a happy and safe holiday season.

Emergency Preparedness



On Monday, November 10, your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Howard Scott, Mike Krahelski, Ric Cox, Tanja Fournier, and Brian Hagadorn. Also present was manager Gus Aarnaes.

The minutes of the October 13, 2008 BOD meeting were approved as corrected. The Action Items and Responses Report from the October 13, 2008 meeting was also reviewed.

The Board reviewed whether the association fine process should be initiated for an ongoing architectural violation relating to improperly stored trash receptacles. It was agreed to begin the fine process.

A more realistic timeline to deal with repeated short term architectural violations such as parking and trash containers was discussed. The Board agreed to allow for a two week follow-up of quickly remedied issues. If a problem can be resolved within a few days, then a repeat offense occurring in two weeks may generate a second letter.

A recess was called to adjourn to Executive Session to review a homeowner's response to avoid their delinquent account being turned over to the Association attorney for collection at 8:10 PM., and the meeting was reconvened at 8:20 PM.

The organization of an Emergency Preparedness meeting for the community was discussed. It was agreed to have a presentation for residents in the clubhouse by the Orange County Fire Authority on January 22.

The latest update on the progress of conversion to the new software by Asyst Data group was discussed, and the system is scheduled for initial installation on Wednesday the 12th.

The final bid for the key fob system was reviewed, and the manager was instructed to obtain references from other communities using the system.

The decision of whether or not to have security guards on duty on certain holidays was discussed. It was agreed that New Year's Eve is mandatory.

The General Meeting notes from North Irvine Villages Association for both the September 10 and October 8 were reviewed.

The financial material for the third quarter ending September 30 was reviewed and approved. Association bank account statements were discussed, as well as the financial material for October 2008. The delinquent account report was discussed, and management was requested to send two 30-day reminder letters and one attorney warning letter to delinquent accounts and three accounts are to be turned over to the attorney upon the deadline.

The Board reviewed the update report on the restroom renovation project. One window and receipt of warranty paperwork remain to be completed.

The Architectural Committee meeting minutes of October 29, 2008 were approved as submitted. The architectural violation log was reviewed.

The meeting was adjourned at 9:40 PM, and the next Board meeting will be held on December 8, 2008.


