
Water Safety Presentation

With the upcoming summer swim season almost upon us, PPHOA has scheduled Orange County Fire Authority to make a presentation on water safety on Thursday, May 7th at 7:00 p.m. in our clubhouse. **Topics will cover pool safety, drowning prevention techniques, and tips for dealing with children of various ages in and around pools.** Our last seminar on earthquake safety was well-attended by Park Paseo residents and this event should be

helpful also. Other topics in this seminar will cover **CPR and First Aid classes** available in the Irvine area. The presentation should take approximately one hour.

Pools/Spa Repairs Completed

The Park Paseo pools & spa repairs have been completed ahead of schedule and are ready for homeowner use in time for IUSD spring break. The northern California company which originally fiberglassed our pools was able to come to southern California earlier than expected and re-do the pool grates and skimmers to comply with new federal regulations.




Photo shows work in progress at the empty Christamon pool.



BOARD HIGHLIGHTS

On Monday April 13, 2009 your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Howard Scott, Mike Krahelski, Ric Cox, Tanja Fournier, and Brian Hagadorn. Also present were manager Gus Aarnaes and five homeowners. The minutes of the March 11, 2009 BOD meeting were approved as corrected. The Action Items and Responses Report from the March 11, 2008 meeting was also reviewed.

The Board reviewed whether the association fine process should be initiated for four ongoing architectural violations relating to house and utility doors needing painting, for wood beams and wood siding needing repainting, for front yard needing refurbishing, and for a garage door needing repainting, The Board also discussed an issue relating to a storage shed being improperly placed on the five-foot easement area on a zero-lot line property which could affect drainage in heavy rains The first violation was corrected by meeting time, the

second had applied for a paint application, the third homeowner has seeded the yard area, the fourth had applied to replace the garage door, and the manager was instructed to send a letter to the homeowner to move the storage shed away

from the easement area. The BOD also discussed a complaint from a homeowner about an abandoned portable basketball unit in one of our streets.

The BOD approved the request of Mary Condy, North-stars co-president for the Saturday meet schedule which includes an intrasquad practice meet on June 6th, home meets on June 20th, June 27th, and July 25th. The BOD also approved practice schedule times for June 1-June 19 Monday-Thursday 3:30-6:30 (4 lanes) and June 22-July 24 Monday-Thursday 3:00-7:30 (3 lanes). The BOD also asked the Northstars to provide the manager with a roster of swimmers to ensure that all members are current on their HOA dues.

The BOD reviewed and discussed the required modifications to our pools and spa and communicated their thanks to Gus Aarnaes for coordinating the repairs so that Park Paseo residents could use the pools in time for the IUSD spring break.

The BOD requested that an IRWD representative meet with our landscape foreman to coordinate the design and installation of water-saving rotating sprinkler heads and possible rebates from IRWD.

Board Highlights (Cont.)

The BOD reviewed and discussed the status of the upcoming aluminum perimeter fence for the Prosa and Christamon pools. Because of increased height requirements to match pilaster heights and changes to gate designs, the BOD approved an increase of up to \$16,000 from the original bid amount.

The BOD acknowledged the Monte family (see photo page 4) at 19 Prosa for winning the May 2009 landscape award.

The BOD reviewed and approved the Architectural Committee meeting minutes of March 25, 2009 and approved an exterior sunscreen installation request that had been sent to the BOD for further study and approval.

The BOD discussed the upcoming Orange County Fire Authority seminar which will take place in our club-house on **Thursday**, **May 7th at 7:00 p.m.** on the subject of **water safety**. The manager was instructed to place an article in the Park Press advertising the event.

Park Paseo homeowner Mike Lennon asked and was granted permission to place large bins outside the club-house to collect food items for the Ten Thousand Pound Food Drive as long as he monitors daily pickup of the items and conceals the empty bins each evening. The event will be publicized locally in the Park Press.

The Board approved the proposed list of duties & responsibilities of the Architecture Committee. The manager was instructed to make final copies available at the next Board meeting.

The Board approved requests by Santiago Hills Elementary School 5th grade for an end of the year swim party. The school will provide two lifeguards and a homeowner will supply the required security deposit. The Board also approved a similar request for the SH 6th grade party and dance the same evening.

The financial material for February 2009 was reviewed. The delinquent account report was discussed, and management was requested to send out five 30-day reminder letters, and four attorney warning letters. One homeowner account is scheduled to be turned over to the attorney for collection.

The meeting was adjourned at 10:15 PM, and the next Board meeting is scheduled for May 11, 2009 at 7:00 p.m.

Lighted House Numbers Required

For homeowners new to Park Paseo, the city of Irvine and the Irvine Fire Department has asked that we remind residents that they are required to provide lighted house numbers on houses. This assists police and fire emergency vehicles in finding homes during emergencies. Ace Hardware in Heritage Plaza still stocks the low -voltage light bulbs for our original lights.
