Lifeguard Service


Because of decreased activity at the pools since school started, weekend lifeguard service at the main pool has

For your information, Southern California Edison is responsible for our street lights and can be reached by phone at (800) 611-1911. Simply follow the voice prompt and report the location by the closest street address. There is also a number on the street light pole that can be reported. If the light is out intermittently, or occasionally on and off, be sure to in-

clude that information.

Please note that the Association CC & R's specifically prohibit any overhanging of plants over a sidewalk that can interfere with the right-of-way of pedestrians. This should also be a matter of common courtesy. The CC & R's state: (Article IX, Section 7) "no tree, shrub or other planting of any kind shall be allowed to overhang or otherwise to encroach upon any sidewalk or other pedestrian way, from ground level to a height of ten (10) feet. Think in terms of the elderly, people with strollers, and especially children on bicycles, skateboards and scooters who may run into these plants. The potential liability should be of concern.

BOARD HIGHLIGHTS

On Monday September 13, 2010 your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Howard Scott, Mike Krahelski, and Brian Hagadorn. Also present were co-managers Gus Aarnaes and Ric Cox and three homeowners. The minutes of the August 9, 2010 BOD meeting were approved as corrected. The Action Item/Responses Report from the August 9, 2010 meeting was also reviewed.

The minutes of the August 25, 2010 Architectural Committee meeting were reviewed and approved. The violation log was reviewed. The Board reviewed an architectural violation regarding tree branches encroaching over a sidewalk. Since the homeowner showed evidence that the tree had been cut back, no fine was assessed.

BOD also reviewed a series of violation letters regarding a front

yard which needed additional vegetation. The BOD voted to insist on a 30-day timeline to add more plants to complete the work. The BOD selected a pebbled concrete trash container design with grey tent-like covers to be placed along our greenbelts. Northstar Swim team officers attended to discuss the successful season and presented Division Championship trophies to the Board.

The BOD voted to trim four eucalyptus trees overgrowing a greenbelt. The Board approved the purchase of wrought iron fences that needed repair or replacement at Campanero E/W, Entrada West, and at Delamesa West at a cost of \$6180.00. The BOD acknowledged the Grinenko family of 40 Diamante (see photo page 4) for winning the monthly landscaping award. The financial material for July 2010 was reviewed. The delinquent account report was discussed and management was requested to send out six 30-day reminder letters. One account is scheduled to be turned over to the attorney for collection.

2011 Budget

During October, you will receive your copy of the budget for 2011. Your Board is now going over expenses for this year and will soon be deciding whether to increase the dues from the current \$81.00 to cover the increasing expenses of maintenance, repairs, utilities, and facility improvements. In these difficult times, the Board is committed to minimizing any increase while providing for the necessary funding to cover the recent on-site reserve fund study requirements as well as projected repair, maintenance, and significant utility cost increases.

The Board has sought to cut expenses in as many areas as realistically possible while utilizing our reserves to repair and update our now thirty-two year old facilities. In this past year we replaced the perimeter fences at both our pools, replaced the roof at the Prosa pool and the spa building, replaced the patio cover at the Prosa pool, replaced many severely cracked sections of greenbelt sidewalks, and re-landscaped the area around the spa. In the next year we need to replace the deteriorating wood patio cover at the Christamon pool and repair and repaint the clubhouse.

Our association continues to be one of the finest in Irvine and especially one of the best values. Your Board continues to be committed to maintaining and improving our assets for all of us to enjoy.

PHONE MESSAGES




