MANAGER'S CORNER

C, C, & R Reminders

Our C, C, & R's (Covenants, Conditions, & Restrictions) which were filed along with the Park Paseo Articles of Incorporation and our Bylaws, outline certain prohibited activities in our community. For example; 'Recreational Vehicles' (RV's, campers, or trailers) may not be parked on our streets or lots except for a six (6)

hour period or for up to forty-eight (48) hours for loading or unloading. No 'Repair of Vehicles' which is visible

from any other lot is permitted. No 'Commercial Vehicles' may be parked or stored on our lots or streets. Garages are for the parking of vehicles and for storage purposes only and shall not be converted for living or recreational activities. Garage doors shall remain closed at all times except for entering or exiting.

The C, C, & R's also state that no animal or bird shall be allowed to make an unreasonable amount of noise, or to become a nuisance. No structure for the care, housing, or confinement of any animal or bird shall be maintained so as to be visible from neighboring lots.

Your PPHOA Board of Directors is charged with the enforcement of these

provisions. While C, C, & R's can be changed, it is a difficult and lengthy process. While these provisions are in effect your Board is charged with enforcing them. When you purchased a home in our community you received a copy of the C, C, & R's and agreed to be bound by them. These documents also provide for an establishment of a voluntary Architectural Committee which governs changes & improvements made to lots. The Committee crafted rules for sheds & storage units and determined that they must not be visible from greenbelts/walkways and must not exceed the height of walls or fences.



BOARD HIGHLIGHTS

On Monday November 15, 2010 your Park Paseo Board of Directors met at the clubhouse for its rescheduled meeting. Present were Directors Howard Scott, Tanja Fournier, Roland Philipp, Mike Krahelski, and Brian Hagadorn. Also present were co-managers Gus Aarnaes and Ric Cox and two homeowners. The minutes of the October 19, 2010 BOD meeting were approved as corrected as well as the minutes from the October 19 and October 25, 2010 Annual Election meetings. The Action Item/Responses Report from the October 19, 2010 meeting was also reviewed.

The minutes of the October 27, 2010 Architectural Committee meeting were reviewed and approved. The violation log was reviewed. The BOD reviewed a 'final' violation letter regarding a satellite cable wire

draped across a garage and, since the homeowner failed to attend or respond to the letter, a

fine of \$25.00 was assessed. A homeowner attended to request more time to repair/replace driveway brick ribbons and uplifted sidewalk concrete and was granted an extension. The BOD set a deadline of November 30 for another homeowner who requested additional time to complete brick repairs in the front landscaping area. A homeowner attended to request consideration for a lost key deposit/charge for not returning the clubhouse facility keys. Since the forfeiture was clearly spelled out in the rental agreement, and insurance considerations preclude the BOD from making an exception, the charge was upheld.

The Board reviewed a request from a Brownie Scout leader requesting fee-waived use for her troop. Since the residency requirement was met, the BOD approved the request. The Board reviewed a homeowner letter requesting further trimming of the trees surrounding the tennis courts and directed management to check with the landscape company arborist to develop a plan for the trees. The BOD acknowledged the Chin family at 7 Alba West (see photo page 4) for winning the monthly landscaping award. The financial material for third quarter 2010 was reviewed and approved. The delinquent account report was discussed and management was requested to send out three 30-day reminder letters. One account is scheduled to be turned over to the attorney for collection.

The meeting was adjourned at 10:00 p.m., The next Board meeting is scheduled for Monday December 13, 2010 at 6:30 p.m.

Thirteen Things Your Burglar Won't Tell You.

- 1. Of course I look familiar. I was here just last week cleaning your carpets, painting your shutters, or delivering your new refrigerator.
- Hey, thanks for letting me use the bathroom when I was working in your yard last week. While I was in there, I unlatched the back window to make my return a little easier.
- 3. Yes, I really do look for newspapers piled up on the driveway. And I might leave a pizza flyer in your front door to see how long it takes you to remove it.
- 4. If decorative glass is part of your front entrance, don't let your alarm company install the control pad where I can see if it is set. That makes it too easy.
- 5. A good security company alarms the window over the sink- and the windows on the 2nd floor which often access the master bedroom-and your jewelry. It's not a bad idea to put motion detectors up there too.
- 6. It's raining, you're fumbling with your umbrella, and you forget to lock your door-understandable. But understand this: I don't take a day off for bad weather.
- 7. I always knock first. If you answer, I'll ask for directions somewhere or offer to clean your gutters. (Don't take me up on it.)
