Moving Soon?




Northstars Swim Team



BOARD HIGHLIGHTS

On Monday January 10, 2011 your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Tanja Fournier, Roland Philipp, Mike Krahelski, and Brian Hagadorn. Also present were co-managers Gus Aarnaes and Ric Cox and one homeowner. The minutes of the December 13, 2010 BOD meeting were approved as corrected. The Action Item/Responses Report from the December 13, 2010 meeting was also reviewed.

The minutes of the January 5, 2011 Architectural Committee meeting were reviewed and approved. The violation log was reviewed. The BOD voted to waive a fine for a homeowner whose residence had visible elec-

tric wires hanging from the exterior of the garage since she has corrected the violation. The BOD heard from a homeowner who

objected to the placement of greenbelt trash cans. After viewing a comprehensive analysis from our landscape company's arborist, the BOD directed management to seek bids to trim some trees that overhang the tennis courts and to remove a number of trees that are so close to the concrete that they could potentially damage the courts. The Board accepted a proposal at a cost of \$305.00 from Earthcare Landscape to replant two Melaleuca trees and an Escallonia shrub that were damaged in the recent heavy rains. The Board also directed management to seek bids for stump grinding of recently removed trees. The BOD, after viewing an oversized truck continually parked in our community, directed management to send a warning letter to the offending homeowner reminding him of commercial parking restrictions.

The BOD acknowledged the London family of 23 Diamante for winning the 2010 Annual Landscape award & the Lin family at 23 Lucero East & the Walker family of 61 Diamante for winning the 2010 Holiday Decorating award. The financial material for November 2010 was reviewed. The delinquent account report was discussed & management was requested to send three 30-day reminder letters, three attorney warning letters, and to turn one account over to the attorney for collection. The BOD adjourned to executive session to examine attorney-recommended procedures to collect delinquent HOA fees from a homeowner.

The meeting was adjourned at 8:10 p.m., The next Board meeting is scheduled for Monday, February 14, 2011 at 6:30 p.m.

Community News Neighbor Watch

As Park Press editor I often hear some wonderful suggestions. A homeowner recently suggested that residents on each street have a listing of all homeowners' names, their family members and their home/work/cell phone numbers in order to help contact neighbors to

help anyone experiencing an unexpected emergency or tragedy. As an example, when a mother in a neighboring community was killed by a driver while jogging,

neighbors and friends were able to rally other neighbors to help with babysitting, driving, and meal preparation while the husband/father tried to keep his family together. This was possible because someone on the street had a list of the phone numbers and names of the residents, created for just such a circumstance.

Park Benches to be Installed

Eight new park benches were ordered in January and are scheduled to be installed in various locations on our greenbelts around March 1. You can find concrete pads located near the recently installed trash cans to determine where the park benches will be positioned. The placement of the benches and trash cans was selected based on traffic patterns on paths in our community in response to requests from community members.

If anyone in Park Paseo is interested in adding a memorial to a loved one to be placed on the benches, please call the clubhouse to inquire about the procedure and cost of the plaque placement.

- Non-electric can opener
- Blankets or sleeping bags
- A battery-powered radio, flashlight, & batteries
- Fire extinguisher-A-B-C type (Charged up)
- Rubber boots, rain poncho, dry socks
- Plastic trash bags
- Sturdy pair of shoes, warm clothing, & personal hygiene items
- Extra cash
