## Summer Pool Schedule

The Christamon and Prosa pool heaters have been turned on so we may enjoy the pools heated to 80 degrees for June through September. During spring, a security guard will be on duty as follows:

Friday 5:00 pm - 1:00 amSaturday 5:00 pm - 1:00 amSunday 5:00 pm - midnight

When school lets out on June 16th, we will add security

guard shifts from 5:00 p.m.— until midnight each day to check homeowners into our facility. We will add lifeguards from 12:00 noon until 6:00 p.m. daily at the Christamon pool (only) starting June 16. The lifeguard coverage will continue until Labor Day.

## **COYOTE SIGHTING**



# **Pool Reminders**

Children under 14 years of age must be accompanied by an adult (18 years or older). The only exception to this is a child who has a valid, registered green tag who may come to the pool any time a life-

guard is on duty. They may not bring guests. Swimmers must be 18 years of age to use the spa without homeowner supervision. Babysitters bringing children to the pool must be physically present at all times with the children and must supervise them at all times. Babysitters cannot be outside the pool area when their children are still inside. Your cooperation is much appreciated.

### POOL GATES

Please do not leave the pool facility entry gates ajar. Help encourage everyone to close the gates! We cannot have unattended children in the neighborhood access the pools. Nor can we have children within the facility exit to the street. There is no inconvenience so great that overlooks the safety of our children.



# **BOARD HIGHLIGHTS**

On Monday, May 9, 2011 your Park Paseo Board of Directors met at the clubhouse for its regularly scheduled meeting. Present were Directors Tanja Fournier, Mike Krahelski, Howard Scott, Roland Philipp, and Brian Hagadorn. Also present were co-managers Gus Aarnaes & Ric Cox. The minutes of the April 11, 2011 BOD meeting were approved as corrected. The Action Items/Responses Report from the April 11, 2011 meeting was also reviewed.

The minutes of the April 27, 2011 Architectural Committee meeting were reviewed and approved. The violation log was reviewed. The BOD approved a bid from Anaheim Fireside at a cost of \$6,000.00 to replace the three barbeques and gas lines at the Christamon pool.

Management communicated to the BOD that all nine of the new benches had been installed on concrete pads throughout the community and the newly ordered trash cans and trash can lids will be delivered soon. The BOD directed management to remove the non-



functioning water fountains in the greenbelts and to relocate the one at the main pool. The BOD discussed the bid from Reserve Data Analysis to conduct the 2011 audit and allocated \$1,600.00 to complete the required yearly study. The BOD also approved the attorney retainer agreement with our long-time legal firm at a cost of \$1,200.00 annually. The BOD also voted to increase our property insurance from \$435,000 to \$650,000 because of increased valuation of the clubhouse and other structures. The BOD looked at paint color schemes and modified the earlier decision to include a darker brown for trim on the clubhouse. The BOD acknowledged the Norton family at 12 Glorieta East for winning the monthly landscape award.

The financial material for first quarter 2011 was reviewed and approved. The delinquent account report was discussed & management was requested to send five 30-day reminder letters, four attorney warning letters, and to turn one account over to the attorney for collection pending receipt of payments.

The meeting was adjourned at 8:49 p.m. The next Board meeting is scheduled for Monday, June 13, 2011 at 6:30 p.m.

# **Community News Summer Safety Tips**

When exercising in hot weather be sure to drink plenty of fluids and wear one layer of light-colored clothing. Never leave a child or pet in a hot car, even for a moment. Make sure metal slides are cool to prevent children's legs from getting burned. Be sure to report damaged equipment immediately.

Children should never ride skateboards or scooters in or near traffic. All skateboarders and scooter riders should wear a helmet and other protective gear; wrist guards, knee pads, and elbow guards.

## Playground Sand In Pools

Our pool maintenance company recently communicated to us that sand is accumulating in the children's wading pool drain since the pools have been heated. It was as though there was more sand in the wader than in the playground! Please understand how harmful this is to the pool pump and circulation equipment and filters. The sand acts as sandpaper on the internal parts of the pumps and the filters plug up prematurely and eventually tear apart and have to be replaced. This becomes a significant maintenance expense to the association.

Please help us all minimize repair and maintenance expenses by not allowing the little ones to run back and forth between the sandbox and pools. Let's all try to keep that sand out of the pools!

## **Recreational Vehicles**

With summer and vacation time rapidly approaching, please be reminded that recreational vehicles, boats and trailers cannot be parked on streets or driveways within the association except to be loaded or unloaded. Longer than one day is a violation of the CC &R's.

When selecting decorative lights, choose Energy Star light emitting diodes (LED's) that are exceptionally energy-efficient and use up to 90% less energy than incandescent bulbs to produce the same amount of light. Switch to CFL's! Replace lights & lamps with compact fluorescent (CFL) bulbs which last up to 10 times longer.

# **Roofing Rip-offs**

Beware of scams, shoddy contractors, and rip-offs when dealing with roofing contractors. Nearly one in three contractor complaints deal with roofing issues, according to state contractor bureaus. Here are some tips to avoid conflicts and headaches when dealing with roofers: Get multiple bids. Check for licenses-roofers are required to be licensed by the state. Ask for referrals from other satisfied customers, preferably in your neighborhood. Don't be tempted by super low bids. The roofing materials and labor all cost contractors about the same amount.
