# February Board Meeting Highlights

On Monday, February 13, 2012, your Park Paseo Board of Directors held its regularly scheduled meeting. Present were Directors Tanja Fournier, Brian Hagadorn, Ric Cox, Mike Krahelski and Howard Scott. Also present were Dana Davidson and Liz Rivera of PCM. Liz was introduced to the Board as the new office manager that replaced Janal Barkley (Janal relocated outside the area and had to resign her position at PCM - she will be missed!). The Board approved the Consent Calendar, which consisted of the January 9, 2012 Meeting Minutes, the January 2012 Financial Statement prepared by PCM (subject to audit) and the January 2012 Delinquency Report. As a reminder to all Park Paseo owners, the Association's collection policy is in full effect and any owner with a past due balance is subject to late charges, interest and additional collection fees and remedies. The Board reviewed proposals to replace the side door that leads from the clubhouse meeting room area to the exterior, on the side that faces the tennis courts. It was decided that a utility-type door should be considered and additional proposals received before a decision is made on the door replacement. As noted in the "Jacaranda Tree Trimming" article, the Board voted to approve the proposal from Harvest Landscape Enterprises, Inc. to trim 130 Jacaranda trees and to remove 1 dead Jacaranda tree, for a cost of \$10,175.00 (a reserve expenditure). The Board also voted to approve a proposal from JOTS to replace the shower tile in the women's restroom at the clubhouse, along with the shower valves and heads, for a cost of \$3,237.50 (a reserve expenditure). The shower tile replacement will be completed during the spring time. Proposals to re-fiberglass the spa, wader and 2 pools, along with the water line and swim lane tiles in each pool, were reviewed and a contractor was selected. Contract negotiations are underway for this major work, which will be scheduled this year and will warrant all bodies of water to be closed for an extended period of time. We will keep you apprised of the schedule for this project once the contract has been signed. The Board voted to renew 2 maturing CDs and to add additional funds to each CD by transferring money from the money market accounts. The meeting minutes from the Architectural Committee meetings that were held in January (January 4th and January 25th) were reviewed and the Board voted to accept them as they were submitted.

# Landscape Updates

Our landscape crew has been given instruction to start trimming down the landscape that is growing along all perimeter common area walls in and around our community. By doing so, the community will end up with a cohesive, uniform look that appears to be the standard throughout Irvine. The common area landscape will be trimmed one brick down from the top of the wall. We bring this to your attention because it will require many of you to secure your landscape that is growing inside your backyard and onto the wall. Once the exterior common area landscape is cut down to the standard, it may impact your own wall coverings if yours is entangled with the Association wall covering. The landscape crew begin to implement this landscape maintenance strategy during the month of March. We ask that you please take steps to secure your landscape now.

# Jacaranda Tree Trimming

Harvest Landscape has been given authorization to trim all Jacaranda trees throughout the community. The work will begin in mid-March and should take approximately two weeks to complete. Many of the Jacaranda trees are located in the center islands of each street. Please be mindful of where you park cars in order to avoid tree debris from landing on or near a car. And for safety reasons please be careful when driving past the tree trimming crew.

# Springtime Home Improvement

Spring is just around the corner, and with that comes plans to improve and maintain our homes: painting, new roofs, windows, new landscaping, etc. Plan ahead and pick up a Home Improvement Application at the clubhouse, or download it from www.parkpaseoirvine.com. Submit it no later than the last Tuesday before the Architectural meeting for approval. Architectural Committee meets on the last Wednesday of every month. Architectural approval must be received prior to starting any exterior improvements to your home.
