Planning Area 5B August Subcommittee Report

Over the last few months, Bob Odell and I have met numerous times with the City of Irvine and the Irvine Company to discuss the concerns Park Paseo homeowners have expressed regarding the soon-to-be-approved 5B development. Those concerns are: a loss of privacy, openness, security, and views caused by the 30 ft. width of the proposed 'buffer' between Park Paseo and 5B, and the density and 4-6 ft. newly graded height of the 5B tract.

On Thursday, August 1, the City of Irvine Planning Commission met to approve/disapprove the tract map zoning for the 5B development. The Irvine Company had earlier conceded that a 30 ft. buffer was inadequate and changed it to 40 ft. They also changed the grading elevation to 1-4 ft. We had 15+ Park Paseo homeowners attending the meeting and numerous spoke before the commission asking for a wider paseo and more assurances that the height, density and orientation of the new homes along the paseo would be "comparable and compatible".

The Planning Commission did approve the 5b project but not before getting the Irvine Company to add another 8 ft. to the paseo (for a total of 48 ft.) and strongly suggesting that tract planning along the paseo include single-family homes, cul-de-sacs, looped streets and lower density to soften the impact to existing neighborhoods even more. I believe our homeowner's participation, along with Canyon Creek's, was instrumental in gaining the Planning Commission's support.

ISSUES MOVING FORWARD:

- There will be more public meetings as the Irvine Company seeks approval for subdivision tract maps which will show specific home type, density, location, etc. Homeowner involvement in those meetings should be encouraged.
- 2. Rough grading of 5B might begin in the next few weeks. The Irvine Company has a Construction Hotline number to call if homeowners have complaints about dust, vermin, noise, etc. during the construction. Contact the Irvine Company Construction Hotline directly at 949-720-2610.
- There will be public access to the paseo from Hicks Canyon Trail, Irvine Blvd., Hicks Canyon Dr. and Park Place. However, the Master HOA of PA 5B will own and

- maintain the paseo. In the future, if homeowners have any disputes or complaints regarding the paseo, they will have to be resolved through the PA 5B HOA. If the issue can't be resolved, the City of Irvine can be brought in to arbitrate.
- 4. We heard from a very reliable source that IRWD is planning on removing the water tank at the end of Orange Arrow. We should be involved in the disposition of that property as it could add another access point from Northwood to the paseo.
