Community Update

The November Board of Directors meeting covered a variety of topics, the most important of which was the upcoming budget for 2016. If you couldn't attend the meeting, here's what you missed:

✓ Assessments will be set at \$104 per unit, per month effective January 1, 2016 (please see related Budget Analysis article).

✓ Preliminary approval of architectural rule changes (please see related article).

✓ Approval of the October 2015 financial statements reflecting operating assets of \$221,670.82, reserve assets in the amount of \$710,725.73, and other assets of \$16,696.46 for total assets of \$949,093.01.

 \checkmark Extension of the pool heat to at least December 15th.

✓ Confirmation of the major project list as determined by the Board in March, which includes continuation of the turf removal and replacement project, lighting and electrical upgrades, clubhouse redecoration, and entry signage and monuments.

 \checkmark Removal of six (6) dead eucalyptus trees, predicated on City of Irvine approval.

Budget Analysis

There was a special budget meeting held on November 17, 2015 due to a corrupted Excel file that resulted in an incorrect calculation at the meeting on November 9th.

Over the years Park Paseo has enjoyed some of the lowest assessments in Irvine, especially given the amenities available to the membership. After extensive deliberation, the Board determined that an assessment increase was necessary in 2016 to cover several items in the budget including the cost of new legislative requirements for pool chemical monitoring and pool chemical expenses. A complete copy of the budget and reserve study summary will be submitted to all members by December 1st. Holiday Decorating Contest! Rule Change Notice

The Board of Directors and the Architectural Review Committee are considering a modification to page 14 of the architectural guidelines to accommodate recent legislative changes as noted in italics below. For details, please see the bulletin board at the clubhouse at 25 Christamon West. Members have until the December 14 meeting to offer suggestions or changes to these potential revisions. Additionally, the ARC form may be modified to clarify which neighbors are signing off to have seen the plans slated for review.

Landscaping: Landscaping components can be defined as (1) hardscape (walkways, driveway, planters, free standing walls, pilasters, etc.) and (2) softscape (grass lawn, flowers, shrubs, groundcover, trees, etc.). All hardscape components must be approved by the Architecture Committee. Landscaping installed must present an attractive appearance for the property and must include a reasonable combination of lawn and/or groundcover, shrubs, and trees, walkways, etc. (See required percentages below for softscape.) Any softscape which deviates from the minimum landscaping requirements must be approved in advance by the Architecture Committee.

1) The following landscaping materials are not permitted within the front and visible without the prior approval of the Architecture Committee.

a) Decorative rock, wood chips, sand, gravel, or any other rock-like substance. However, these materials may be acceptable when installed as an accent in the visible areas. Non-plant decorative materials are not to be used as substitution for hardscape, lawn or groundcover.

b) Hedge-type plants and/or shrubs with thorns planted adjacent to sidewalks.

c) Artificial Turf.

2) The following minimum softscape requirements for the front and/or side yard property are:

a) Eighty percent (80%) of the front and side yards planted in groundcover, *artificial turf*, or grass lawn, or a combination thereof.

b) Twenty percent (20%) of front yard planted with shrubs.

3) Drought-tolerant plants are encouraged. For a list of preferred drought-tolerant plants, please visit the Irvine Ranch Water District's r e c o m m e n d e d w e b s i t e a t www.rightscaperesources.com.
