Prosa Pool Winter Costs

A few homeowners recently attended a Board Meeting to request that the Prosa Pool remain heated through the end of December, since the Clubhouse Pool was closed October 1st for the deck project. The Board listened to the homeowners and the pool will remain open through December at an approximate monthly cost of \$2,484. Thank you, Board!

2021 Budget

The 2021 Budget reflects an assessment increase to \$122.00 per month, a \$4.00 per month increase. This increase is necessary to:

- Adequately cover the rising operating utility cost increases for gas, electric and water.
- Cover contract increases for landscaping janitorial, pool and patrol services.
- Support the State-mandated minimum wage increase.

With this budget, the Board of Directors does not anticipate that any special assessments will be required to replace, repair or restore any major component of the reserve program in 2021. The 2021 budget will be mailed out in November and becomes effective with the January 2021 payment. If you use auto-payment through your bank, update the amount to \$122.00 effective with the January 2021 payment to avoid late fees. If you use auto debit through PCM, the amount will automatically be changed.

CLUBHOUSE, POOL & DECK PROJECT UPDATE

Demolition has started on the Clubhouse. The total costs for the project is \$474,000, which includes demo, plumbing, coping, electrical, pavers, ADH ramp, BBQ area and more! The Clubhouse remains closed due to COVID-19 restrictions and no reservations are being taken at this time. The TENNIS COURTS are OPEN. A new outside gate has been installed and the pool entrance key allows access. Sign-up sheets are inside the tennis courts. The Clubhouse Pool area and parking lot remain closed for construction.

The revised certified audit of Park Paseo HOA contains corrected financial statements that includes these expenses. Please disregard the originally issued audited financial statements.
